2. Introduction and Background

About Us

The contracting organization is a faith-based Humanitarian and Development organization working in 24 countries of the world. We began working in Pakistan in 1982, responding with humanitarian assistance to Afghan refugees in Khyber Pakhtunkhwa (KP) province. The organisation has since helped communities affected by the earthquake in 2005 and has from 2007 expanded its operations with long-term development and humanitarian aid. Our work is guided by the following values: Integrity of Creation, human dignity, global justice, inclusive communities, and compassion. The organization participates in the UN Clusters and is a member of the Pakistan Humanitarian Forum (PHF) and other networks. We are dedicated to internationally recognized standards and commitments:

- Core Humanitarian Standards on Quality and Accountability (CHS).
- Sphere Humanitarian Charter and Minimum Standards in Disaster Response.

- ACT Alliance Code of Conduct.
- Code of conduct for International Red Cross and Red Crescent movement for NGOs in Disaster Relief
- Do No Harm

Description of Grant/Project

Since 2004, our peacebuilding programme has longstanding collaborative experience in working with various faith communities and civil society organizations to promote tolerance and intra/interfaith dialogue in Pakistan. Through this, we contribute to strengthening gender sensitive community structures for conflict transformation and employ advocacy initiatives to promote dialogue among key religious leaders of different faiths on sensitive issues.

In October 2014, a three-member delegation from the ACT Church of Sweden (CoS) visited Pakistan to explore potential avenues of cooperation with local and ACT member organizations. After much deliberation, the delegation decided to scale up our Peace Building (PB) and Gender equality, protection & respect programmes in Islamabad, Khyber Pakhtunkhwa (KP), and Sindh provinces. From 2015 – 2022, ACT CoS supported our PB programme in three phases. **Phase 1:** 2015; **Phase 2:** 2016 – 2017; and **Phase 3:** 2018 -2022.

Based on the foundations of the earlier work, the contracting organization has initiated a 3-year project titled Faith in Action for Equal Rights and Opportunities for All- Phase-II. The project will directly benefit 8,153 individuals concentrated in 7 Union Councils (UCs) of Chitral and Peshawar districts in three years (1-1-2023 to 31-12-2025). The project theory of change envisages three interconnected changes. First, diverse faith communities promote social cohesion to counter violence, Second, communities protect social action for peace through coordinated advocacy. Third, women's meaningful participation in social cohesion and political processes increased. The project ToC is built on assumption that "If key actors of the target areas are mobilised and instrumental in playing an active role for promotion of social cohesion and intra/interfaith harmony, then they will reduce acceptance of violent extremism and encourage more social contract for multifaith initiatives. As a result, the society will be more inclusive, cohesive, and peaceful because stereotypes will be countered and misunderstandings will be resolved amicably, bringing people close to each other.

The project is an effort to facilitate spaces for interaction and coordination among different social groups to minimize misunderstandings and stereotyping. The project will mobilize male/female faith actors and civil society representative for their active role in promoting intra- interfaith dialogue, curbing hate speech, and countering violent extremism. The project also focuses on strengthening civil society for joint advocacy with duty bearers to address conflict drivers and increase space for joint social action. It will contribute to development, improvement and better implementation of laws and policies to protect the rights of religious minorities in Pakistan. Project will ensure active women participation in peacebuilding and leadership roles through capacity building and sensitization initiatives.

3. Target Audience

This baseline study intends for Project Implementation partner, Commissioning Organization, and Donor Organization.

4. Objectives of the baseline

The main purpose of this assignment is to conceptualize the baseline study in line with the planned results (outputs, outcomes, and goal/impact) of the project, and carry out the survey to provide a sound basis for the project results monitoring, and formative and summative evaluations. This study is to establish benchmarks for project's impact and outcome indicators against which project results will be measured. Specifically, the baseline will serve the following specific objective:

- Determine the baseline values of applicable indicators provided in the project's Results Framework to set benchmark against which change can be measured at the mid-term and the end of the project.

5. Baseline Scope and Methodology

The baseline will be conducted in five Union Councils (UCs) of Peshawar district and two UCs of Chitral district of KP province. Advocacy activities will focus on the improvement of gaps in the legislation at the provincial level. The names of the targeted UCs in Peshawar and Chitral districts are as follows:

The total direct beneficiaries of this project are 8,198 individuals (4,763 male, 3,390 female and 45 trans-persons). This includes women, men, youth journalists, civil society activists and faith actors in selected UCs of district Peshawar and Chitral. To accomplish the objectives of the baseline study, the contracting organization expect consultant to propose a comprehensive methodology in accordance with the nature of the objectives, and source and disaggregation of the data required for indicators to be measured. The proposed methodology should apply a combination of qualitative and quantitative tools with data quality controls and explore existing resources to triangulate the findings. Also provide a critical commentary in analysis. The application shall detail the approaches of data analysis for both qualitative and quantitative data.

In case data from authentic sources exist, we intend for a commentary on indicators in national and provincial contexts to understand the situation outside of the programme implementation areas.

The results frame of the project is composed of global and country specific indicators. A comprehensive methodology for measuring the global indicators will be available to selected consultant. The contracting organization envisioned quasi-experimental design, more specifically the pre/post-tests within subjects to measure the desired effects of the project. Considering the type of beneficiaries, the consultant shall provide a comprehensive sampling methodologies for both quantitative and qualitative data collection methods while explaining inclusion and exclusion criteria. For the quantitative aspects the consultant shall consider the 95% and 5% confidence level and margin of error, respectively, to draw sample size.

8. Team Composition and Requirements

Field Team:

- Demonstrated understanding of religious and political landscape in Pakistan and role of religion in Pakistani society.
- Preferably, the applicant affiliated with reputable research institution or consultancy firm (from Pakistan).

b) Experience

- Eight to ten years of experience in designing, managing, and implementing impact assessments/studies, evaluations, research, and the use of mixed methods. Preferably some evaluation experience of peacebuilding programmes within conflict sensitive countries, like Pakistan.
- Demonstrated understanding of gender issues, gender mainstreaming, and peacebuilding within evaluation;
- At least 10 years of experience in working with government officials, media, marginalized groups including faith minorities, faith actors and institutions, and people and children of conflict sensitive diverse communities;

c) Behavioural

- Treats all people fairly and equally and does not discriminate against any individual or group.
- Treats colleagues, partners, stakeholders, clients and counterparts with dignity and respect, and works without bias

- Communicates orally and in writing in a clear, concise and impartial manner
