Who is qualified to apply?

As an investor, you need to meet the complying with standards to join the program:

- Be a non-European citizen

In order to follow the Motivation of Financial Investment Act, you must offer a [Bulgarian Citizenship Application](#) certification issued by the Bulgarian Ministry of Money. One of the most secure means to obtain such an investment certification is to invest in a Bulgarian federal government bonds portfolio. The financial investment is totally protected and ensured by the Bulgarian federal government.

As a qualified financier in BG IIP, you can pick between two investment choices to take part:

Full Investment Alternative - you shall deposit the total of BGN 1,000,000 (EUR 511,292) for 5 years. At the end of the fifth year, this amount is reimbursed to you without accrued interest.

For the full financial investment option, you should demonstrate individual or family members consolidated net properties of at least EUR 511,292. Most typical properties acceptable for taking part in this program are cash money, property, service and financial investment certifications, including bonds as well as supplies.

Financed Investment Option - you shall transfer a reduced quantity of EUR 170,000. This quantity is utilized to finance a 1,000,000 BGN (EUR 511,292) closed five-year term loan from a legal Bulgarian bank. The amount of EUR 170,000 is not refunded to the capitalist at the end of the 5th year, given that it is used to cover the small business loan costs.

For the financed financial investment option, you must show individual or family combined net assets worldwide of greater than EUR1 million. Most common assets appropriate for participating in this program are cash, property, business as well as investment certificates, consisting of bonds and stocks.

On the basis of this financial investment, you are thought about "special" by the Bulgarian state, according to the regulation in force, as well as you are given Permanent Residential status for 5 years. After 5 years, you might look for Bulgarian passport and Bulgarian citizenship.

Lawful Background of the BG IIP

The legal provisions of the Bulgarian Financier Program for Residence and also Citizenship are mentioned by an change in the Immigrants in the Republic of Bulgaria Act (FRBA) regulation as well as published by The Bulgarian State Gazette, problem 36 (May 15, 2009).

Invest Bulgaria Agency is a department of the Bulgarian Ministry of Economic Situation, Power, and Tourism, and is recommended to advertise and also support the Bulgarian Financier Program for Residence and Citizenship.
