He appealed the conviction and was granted a new trial, but was again convicted and sentenced to the same term.

Jennings would eventually face charges of first-degree murder. The trial is still pending, as of this writing.

## **Republican Child Molesters**

Republican George Nader, an adviser to the Trump campaign and presidency, was tried for transporting sexually explicit materials in foreign commerce in 1985, for which the charges were dismissed. He was tried for the same offense again in 1991, and a federal court sentenced him to a six-month jail term and a \$2000 fine. Both cases involved print and film media of "pre- and post-pubescent boys." In 2002, he was convicted of molesting multiple underage boys, and received a one-year prison term. Nader is credited with introducing his client, Abu Dhabi prince Mohammed bin Zayed, to several key members of the Trump administration, like Jared Kushner and Steve Bannon. He also apparently set up a meeting between bin Zayed, Erik Prince, the brother of Trump's Education Secretary, Betsy DeVos, and Kirill Dmitriev, a Russian banker with close ties to Vladimir Putin. Nader agreed to cooperate with Robert Mueller's investigation into Russian tampering of the 2016 election, after Mueller issued Nader a subpoena and had his electronics seized in January 2018. A federal grand jury indicted Nader in 2018 for possession of child pornography and importing a 14-year-old foreign minor into the country for sex. In January 2020, Nader pleaded quilty, and received a sentence of 10 years in prison, the minimum for his offenses. Nader also agreed to pay restitution of \$150,000 to his victim.

Republican ex-Speaker of the House Dennis Hastert pleaded guilty to illegal bank withdrawals of \$952,000 to avoid reporting requirements. As part of the deal, he admitted during his sentencing that the money was for payments related to "wrongdoing in his past." The wrongdoing turned out to be molesting at least five male students when he was a high school teacher; he had reached an agreement with one of his victims to pay \$3.5 million in exchange for the victim's silence. Hastert was sentenced to 15 months in federal prison, and served 13. He was also fined \$250,000 and required to enter sex offender therapy. He was never charged for the molestation because the statute of limitations in Illinois had run out.

Simcox represented himself in court and sought to interrogate his victim on the stand. A lower court blocked the action, so Simcox called upon an advisory attorney to question her instead. The right of the accused to directly question an accuser may reach the Supreme Court. Simcox challenged John McCain for his Senate seat in the 2010 Arizona primary, but lost.

Republican William Randall, retired minister and former Congressional candidate, was arrested for sexual battery of a child under 18. He was released on a \$25,000 bond. The victim had first come forward in 2015 with allegations that Randall had been molesting her since 2007, when she was 12 years old, and attempted to buy her silence with money and lunches at restaurants. In the 1980s, Randall was convicted of writing a \$1300 bad check and failing to pay around \$30,000 in income taxes. While running unsuccessfully for Congress in 1998, Randall demanded that Bill Clinton resign over his sexual peccadilloes.

Republican Paul Pressler of Texas became the subject of a \$1million lawsuit alleging that he had sexually molested a young man for several decades starting when the boy was 14. A Democratic legislator in the 50s, Pressler switched parties in the 1970s, became a judge on the 14<sup>th</sup> Court of Appeals, and led a Southern Baptist conservative fatwa to purge the church and its leadership of liberals and moderates. The plaintiff alleges that the abuse, which included anal penetration, started when he was a bible student under Pressler's tutelage in the late 1970s, and continued even after he went to college in 1983. In 1989, President George HW Bush had tapped Pressler to lead the Government Ethics Commission, but withdrew the offer after an FBI background check revealed unspecified "ethics issues." Pressler and his accuser had previously reached a settlement over an assault charge in 2004. Pressler denies all of the allegations.

Republican former governor Neil Goldschmidt (OR) was accused of sexually abusing a 13-year-old girl in a Pulitzer-prize winning series of stories in 2004. The victim claimed that Goldschmidt had started grooming her when she was 7 or 8 years old, and continued to molest her for 14 years. Goldschmidt was 35 when the sexual abuse began. After the

molestation ended, Goldschmidt paid her off to remain silent. Charges could not be filed because the statute of limitations had fallen under an old law that required reporting molestation offenses after three years. The victim died in a hospice after decades of struggling with an addiction to drugs and alcohol. Revelations emerged that other girls had been victims of Goldschmidt as well.

Republican state representative Jim Knoblach of Minnesota unexpectedly ended his re-election bid when his 23-year-old daughter publically alleged that her father had been touching her in inappropriate ways since she was nine years old. Worse, she had reported the abuse to family, friends and even her school and church for at least a decade. An investigator also told her that her father's behavior didn't qualify as criminal. Her own mother had dismissed her concerns and discomfort by saying that her husband had no sisters, so he didn't know how to interact with girls. Desperate to be heard and have someone hold her father accountable for his molestation, the daughter finally contacted Minnesota Public Radio and shared her story with reporters. She said that it was ordinary for Knoblach to put her on his lap while watching TV to bite and lick her neck, to hold her down and forcibly kiss her, to lay in bed next to her, and to press his body against hers from

behind and not let her free. Knoblach had served eight terms in the Minnesota House, and was the chair of the powerful Ways and Means Committee.

Republican state representative and pastor Dan Johnson of Kentucky has been accused of sexual assault of a parishioner in his church after a New Year's Eve Party, when she was 17 years old. While the age of consent in Kentucky is 16, state statute 510.060 states that an adult having sex with anyone under the age of 18 when the defendant is in a position of authority or trust over the child constitutes rape in the third degree. Johnson was notorious for claiming in a Facebook post that President Obama and his family were a "bunch of monkeys." Despite claiming that the molestation accusation was "fake news" and refusing to resign his position, Johnson committed suicide only one day after the lawsuit was reported in the media. Johnson's wife, Rebecca, accused the left of manufacturing lies about her husband, despite police evidence to the contrary, and ran to fill the vacant seat. In February, 2018, she was defeated by 36 points in a district which Donald Trump won by 50 points over Hillary Clinton, an 86-point swing.

The 27-year-old sister-in-law of Lee Chatfield, former Republican Speaker of the House in Michigan, filed a criminal complaint against him for molesting her when she was attending his parochial school and church, starting when she was 15 and continuing until July 2021. Michigan's Attorney General joined the investigation at the end of January 2022, and Chatfield claimed that the relationship was a "consensual affair" and 0"between adults." Chatfield became Michigan's youngest House Speaker in 2019 at the age of 31, a post he held until he was term-limited from office in 2021. While he was a legislator, Chattenfield was arrested for attempting to bring an unregistered firearm onto a flight at Pellston (MI) airport. Unfortunately, his sentence required only that he pay fines for the lack of registration and to the TSA for the attempt to board with a gun. Chatfield is also under investigation for misappropriation of public funds while in the Legislature. In light of both

the financial and molestation allegations, the current Michigan legislative leadership has requested that members and staff retain all records related to Chatfield's time in office.

Two adult children of Republican legislative candidate Rick Roeber (MO) accused him of abusing them when they were children during scheduled visitations. His son, Samson, said that his father was physically abusive, while his adopted sister claimed Roeber started molesting her when she was 9 years old. Another sister claimed sexual abuse as well, and both Roeber's ex-wife and a fourth child attested to knowledge of the abuse. A Child Abuse and Neglect Review Board investigation conducted in 2001 affirmed that there was probable cause regarding sexual mistreatment of the unnamed child, but the decision was overturned two years later and the entire matter put under seal. Roeber denied the charges and further claimed that anything wrong he might have done was when he was abusing alcohol. Despite these revelations of child abuse and molestation just over a month before the election, voters in his district put Roeber in office. Later, Missouri Republicans would expel him from his House seat after their own investigation of the charges found them credible.

Another victim claimed that McGuire assaulted her when she was between the ages of 12 and 13, but her case was not part of the trial convicting him.

Republican Joel Greenberg, Seminole County (FL) tax collector, pleaded guilty to six criminal counts: Sex trafficking of a minor, aggravated identity theft, wire fraud, production of a false document, stalking, and conspiracy against the US. Greenberg was indicted after allegations arose that he abused his power by using the DMV database to look up information on a minor, and stealing expired or confiscated drivers' licenses to create fake IDs, a number of which were found during the execution of a search warrant at his home and office. Greenberg also ordered his employees to open-carry firearms, and invented a badge for his office that he used to attempt arresting people for non-tax related offenses, such as traffic violations. Greenberg also created fake social media accounts to smear a political rival as a child molester. The Greenberg investigation revealed his connection to Republican Congressman Matt Gaetz, and sources told the New York Times that Gaetz was also under investigation for sex trafficking of a minor. In exchange for pleading guilty, the DOJ dismissed 27 other charges against him, but Greenberg must pay a restitution of \$655,000 to his victims, including Seminole County taxpayers. He also agreed to provide "substantial assistance" to investigators before a judge will rule on his final sentence.

He apparently paid some of his victims with heroin for sex. The crimes occurred between 2004 and May 2017 and involved 19 victims. He pleaded guilty to 21 counts of human trafficking, and accepted a sentence of 20 years in prison and a \$100,000 fine. He must also register as a sex offender for life and pay \$10,000 to the Human Trafficking Victims Fund. However, part of the plea deal made him eligible for parole in 4 years. Several of the pleas were Alford pleas, meaning that Nolan

could possibly appeal them in the near future. Despite Nolan's guilty pleas, his lawyers still tried to accuse the victims of lying and the court of being biased by recent sexual abuse stories in the media. In May 2018, at his final sentencing hearing, the judge forced Nolan to listen to letters written by his victims about the effect he had on their lives. In 2016, Nolan served as co-chair of Donald Trump's presidential campaign in Campbell County.

Republican Beverly Russell, County Chairman of the Christian Coalition, sexually molested his step-daughter, Susan Smith, who later drowned her two children.

A photo on the front page of the website Trump Dating was removed after it was revealed that the male half of its model couple had been convicted of molesting a 15 year old girl when he was 25. North Carolina Republican Tea Party activist William Barrett Riddleburger was convicted after he filmed himself molesting the girl and the tape became known to police. In 2014, Riddlerburger and his wife Jodi, also featured in the dating photo, filed a defamation suit against a local blogger for writing satirical pieces lampooning them for the past conviction, but "offered settlement terms" after the lawsuit backfired on them.

Republican author and public scold John Perry had a civil suit filed against him for alleged molestation of girls between 11 and 13 years of age, after 'a police investigation launched in 2012 found the allegations against Perry "were sustained," according to a police department spokesperson, but that statute of limitations had passed.' Perry had held a leadership role in Covenant Presbyterian Church, but church minutes filed in an unrelated court case stated that he was excommunicated because he had "confessed to committing heinous and repetitive sin [...] and has not shown evidence of repentance." Perry's ex-wife "filed for divorce as a result of Mr. Perry's inappropriate marital conduct, to which he admitted to in his Response to Interrogatories numbers 1 and 2." Throughout the court documents, "inappropriate marital conduct" appears to be a euphemism for the alleged molestation.' Perry had co-written morality books with Republican Senate candidate and Alabama Supreme Court Justice Roy Moore, now a known predator of underage girls, and with Republican Presidential candidate and former Arkansas governor Mike Huckabee.

YouTube banned the channel of QAnon Republican Mike Penny for repeatedly inviting a convicted child molester onto its show. Said molester, QAnon Republican David Todeschini, was convicted in New York in 1999 for committing sexual abuse in the first degree and sodomy in the second degree, both against an 8-year-old boy. The state also listed him as a Level 3 violent sex offender, the highest rating indicating that the perpetrator is at "high risk of repeat offense and a threat to public safety." Todescheni, like so many Republican hypocrites, made false claims on Penny's channel (and numerous other outlets) that Democrats were part of a global child sex trafficking ring.

Registered Republican Jerry Sandusky was convicted of 45 of 48 counts of child molestation while an assistant football coach at Penn State University, and sentenced to 30-60 years in prison. Head coach Joe Paterno, also a registered Republican, knew of Sandusky's assaults

for years, and did not report him to police. Sandusky's son, Jeffrey, 41, plead guilty to 14 charges of solicitation of statutory sexual assault and solicitation of involuntary deviate sexual intercourse in 2017, crimes punishable by up to 8 years in prison. His victims were two sisters, aged 16 and 15.

Republican Josh Duggar, executive at the Family Research Council and infamous as one of the Duggar children from the reality TV show 19 Kids and Counting, publicly confessed to molesting five minors when he was between the ages of 14 and 15. His father, Jim Bob Duggar, had received reports as far back as 2002 of his son touching his younger sisters inappropriately while they slept. The elder Duggar attempted numerous punishments, before sending his son to a counseling program. Only after an unidentified person found records of the molestation in a family bible in 2006 was Jim Bob Duggar forced to file police charges about his son's offenses. In April 2021, Duggar was charged with receipt and possession of pornography of children under the age of 12. At least one of the files depicted molestation of a child as young as 18 months old. Duggar allegedly used a dark web application to circumvent anti-porn lockdowns his wife installed on their computer. His fundamentalist wife and parents are "standing by him." In December, 2021, Duggar was convicted of downloading and possessing child sex abuse images on his computer. He faces up to 20 years in prison and fines of up to \$250,000 for each offense he committed. His sentencing will take place sometime between the 8<sup>th</sup> and 23<sup>rd</sup> of January, 2022.

Republican pastor Bob Coy, former head of the largest megachurch in Florida, was accused of child molestation after a California woman called authorities to report that she had just learned of the molestation of her daughter starting when she was 4 years old and lasting into her teens. So far, Coy has not been charged. He was removed from his ministry in April of 2014 for "a moral failing" that the church chose not to disclose. Calvary Chapel in Ft. Lauderdale has over 20,000 members.

The Snohomish County (WA) Sheriff's Office arrested and charged Republican youth pastor Kendal Kippen on three counts of third-degree child rape. Kippen, then 22, had worked at Jake's House Church in 2017 and 2018 and is accused of grooming a 15-year-old congregant through social media and when driving her home. Another victim soon emerged

claiming Kippen had begun abusing her in 2016, when she was 17. As with the other victim, the grooming started via social media. She said he started out with normal chatter, that proceeded to sexually explicit messages and then nude photos. On approximately five occasions, he touched her inappropriately at a church-sanctioned summer camp. In November 2020, the church announced to the congregation that they had removed Kippen from church leadership over multiple allegations of sexual abuse of minors; they further encouraged anyone with complaints to report them to the local Sheriffo's office. The then-lead pastor at the church, Keith Kippen, father of the accused, stepped down, but a year later announced plans to return. The entire church leadership resigned in protest, and Kippen pere's comeback tour was cancelled. Law enforcement and several members of the congregation have stated that they believe more victims exist, and have requested they come forward. To no one's surprise, Kippen also had an active Twitter account where he retweeted numerous remarks by well-known conservatives like Ben Shapiro and Joseph Peterson.

## **Republican Child Sex Traffickers**

Republicans Gary and Shereen Wiggins had eight boys, aged 10-17, removed from Joshua Home Ministries, a "gay conversion therapy' boarding school that they owned in Bertram, TX. The Wiggins duo had similar facilities in Alabama and Missouri, and had run into trouble with local child welfare officials for their treatment of children. In Alabama, children who managed to run away from the boarding school there, "Blessed Hope Boys Academy," described horrific abuse of beatings, solitary confinement and food deprivation. The boys were also expected to work for Mr Wiggins' moving and lawn care companies, without compensation. When law enforcement started sniffing around, the Wigginses packed up and left for Missouri, only to have the same pattern repeat itself, of abuse allegations, investigation and skedaddling out of state to avoid criminal charges. After learning of the couple's new facility, Missouri alerted Texas law enforcement about their investigation, and local law enforcement opened their own. Police soon filed charges against the Wigginses, who were arrested in Alabama and extradited back to Texas, and Child Protective Serves assumed custody of the children. A Texas grand jury indicted the Wigginses for neglect, abuse, licensing violations, labor violations and child human trafficking. Bail was set at \$100,000.
