9th GRADE REQUIREMENTS

1. **9TH GRADE MEDICAL REQUIREMENTS INCLUDE A PHYSICAL EXAMINATION ON THE STATE OF IL FORM AND A COMPLETED IDPH DENTAL EXAM FORM ARE REQUIRED FOR HIGH SCHOOL ENTRANCE (SPORTS PHYSICAL IHSA FORMS ARE NOT ACCEPTABLE).**

2. Complete immunization records must be included for Tetanus/Diphtheria/Pertussis (Tdap), Polio, MMR (Measles, Mumps and Rubella) Hepatitis B, Meningitis(MCV4) and Varicella.
3. The Health History section (yes/no questions) must be completed, signed and dated by the parent/guardian of the child.
4. Return the completed physical form to Health Services prior to the start of school for processing. 9th grade physical examinations may be used for athletic participation for one (1) year.
5. Please make every effort to have the completed 9th grade physical and immunizations submitted to school prior to Pick Up day. Please bring school health records to Pick up day if you are unable to send them in beforehand
6. **Students will be excluded from school on and after August 21, 2023 until complete immunization records, physical examination with parent/guardian health history completed and dental exam form has been received and approved by Health Services.**

12TH GRADE/SENIOR REQUIREMENTS

1. Two doses of Meningitis(MCV4) vaccination are required for entry into 12th grade. Any child entering the 12th grade shall show proof of having received two doses of meningococcal conjugate vaccine prior to entering the 12th grade. The first dose shall have been received on or after 11th birthday, and the second dose shall have been received on or after the 16th birthday, at least eight weeks after the first dose. If the first dose is administered when the child is 16 years of age or older, only one dose is required.

2. Senior students will not receive a registration packet on Schedule Pick-up Day until the required vaccination information has been received and approved by Health Services.

3. **Senior students will also be excluded from attending class on or after August 21, 2023 until documentation of the required vaccine has been received by Health Services.**

TRANSFER STUDENTS

1. Students transferring from an Illinois school must present a copy of their ninth grade school physical examination and a complete immunization record at the time of registration.
2. Students transferring from another state or country must present current immunization records and physical examination at the time of registration.
3. Students transferring to an Illinois public school for the first time are required to have a vision examination conducted by a physician or licensed optometrist and submitted to Health Services.

HEALTH CONCERNS

1. If your child has specific health concerns, please note these concerns on the Illinois Certificate of Child Health Examination form. Contact the school nurse at the beginning of the school year to coordinate care and plan for potential emergency response.
2. Please remember to update emergency contact information as needed throughout the school year.
3. As of January 2017, Illinois State law (PA 99-0843) requires that an Asthma Action Plan be requested from parents of children with asthma. An Asthma Action Plan is a written plan developed by the child's physician indicating how to treat and control their asthma symptoms during the school day. The Asthma Action Plan is to be submitted to Health Services at the beginning of the school year. The plan will remain valid for the current school year and must be renewed each school year or when updated by the physician, or as requested by the school nurse.

MEDICATION

All over-the-counter and prescription medications taken during the school day **MUST** have a District 99 Medication Authorization form on file in our Health Service office signed by the prescribing physician and parent. **Students are prohibited from carrying medication or storing medication in their lockers.**

Asthma and emergency epinephrine medication are the only medications permitted to be carried by the student. Please inform the school nurse if your child will be carrying these medications.

Dear Parent or Guardian,

The State of Illinois has revised the requirement for the Meningococcal vaccine of students entering the 12th grade. Two doses of the Meningococcal vaccination are required for entry into 12th grade. The first dose must be given on or after the 11th birthday, the second dose shall be received on or after the 16th birthday, and at least eight weeks after the first dose. **If the first dose of the Meningococcal vaccine is administered on or after the 16th birthday; then only one dose is required for entry into 12th grade.**

Our records indicate your child has not received a Meningococcal vaccination on or after the age of 16. Documentation of the Meningococcal vaccination, signed and dated by a healthcare provider, must be provided to the nurse's office by the start of the school year.

12th grade students must submit the required vaccination information. Students will be excluded from attending class on the first day of school, and every day thereafter, until documentation of the required vaccine has been received by Health Services. Please schedule an appointment immediately with your child's healthcare provider to receive this vaccine.

Depending on your insurance, you may also be able to receive the vaccine through the DuPage County Health Department. Appointments may be scheduled at the DuPage County Health Department by calling 630-682-7400. Please contact your physician or the Nurse's Office with questions:
