Please note that although in preparing the summary I made a good faith effort to convey the substance of Todd's remarks using the notes I took during the meeting, the content of the summary is attributable to me only, and the content therein shall in no way be construed as binding or even attributable to Todd or the ACN program.

Thanks once again to all who participated in meeting 5.0! Old friends, occasional

participants (who I hope become regulars!) and new faces - we had an impressively diverse group indeed. We look forward to welcoming those who plan to join the ACN (or return to the flock) to future meetings. As I've said before (and am about to say again, no doubt), this is simply a great time to be associated with Apple and with the ACN.

Summary of Todd's remarks:

-ACN's predecessor program was the "Apple Solution Expert" organization, which due to conflicting nomenclature issues as well as other limitations was put to rest in 2002 as a consulting organization (ASE plans still exists in Europe and Asia as reseller programs), and the Apple Consultants Network, as we know it today, was born.

-The ACN runs as a P&L organization within Apple, and as such must be independently viable economically. Therefore, the program needs to be built up inside of Apple in order to obtain the resources it requires to be considered attractive to high quality consultants.

-Certification is key if the ACN program and ACN members are to be trusted and well thought of within Apple. It is considered by the ACN leadership that if a consultant is serious about working with Apple, he or she should be serious about getting certified. That is why, after 2 years as an optional component of the ACN Program, certification became mandatory in early 2004, with member consultants given until July 1st to obtain at least the entry level certification.

-Once all members are certified, there is no longer an issue with which members are allowed

to use the ACN logo (all members are, since all are now certified members).
-Apple has sent various ACN awareness emails to its customer databases.
-The ACN's main goal is to make it's members successful business people. The relationship between Apple and ACN members is a synergistic one.
-No other program within Apple can offer the resources that the ACN can: 1100 members that can do everything from plugging in Grandma's iMac to putting together computing clusters on Active Directory.
-Through Todd's leadership, various groups within Apple are looking to the ACN program to help them achieve their goals.
-OS versioning is a definite issue as it relates to certification. The ACN program will likely adopt a "rolling" version requirement: members' certifications must always be within 2 versions of the current, shipping OS version. New members must be certified in the current version.
-The ACN website is undergoing various changes which will to enhance its capabilities as a best-of-breed resource for customers and as a sophisticated lead generator for member consultants. For example, the website now refers to ACN members as "Apple-certified" consultants. Leads will reflect certification levels as well as member profiles. The website will in the near future allow the customer to choose a consultant, and manage the referral to ensure routing to a consultant well qualified for the job, timely response to the customer and the "rating" of the consultant based on various factors, including the consultant's reliability and the customer's opinion. The general idea is for the website to properly match leads to the right consultants, and for the website to allow the ACN leadership to closely track leads, referrals and resolutions.
-The Hardware Demo pool is an excellent resource for member consultants, both as a selling tool as well as a training tool.

-Apple retail stores:
>

-Apple retail store employees are apple-badged, and are therefore strictly prohibited from moonlighting as consultants. Inside the store is Apple employee territory; outside the store is ACN territory.

-National average: 10-15 referrals to ACN members each day per store.


-New card will be handed out to customers simply promoting the ACN website (no particular consultant's name), so that customers can then enjoy the new capabilities of the website.

-Business Agent Program: Allows participants to act as Apple's representatives with regard to hardware and software sales, making a percentage of the sale price while Apple handles order entry, fulfillment, collection, etc. Could be an excellent option for ACN members with no Apple retail store in their area. However, Business Agent Program is mutually exclusive with Channel Referral Program.

-There are 147 links to the ACN website in the apple.com domain. More are being added constantly.

-50% of Todd's time is spent dealing with member issues. Coming to him with a problem is not constructive. Coming to him with a problem and a well thought-out solution is constructive.

-CompUSA: currently testing Pro Days program hosted by Apple-badged employees. Today, Dallas. Aug 9th - 9 other cities. October: national rollout.
