- **General Information:**

- There are no waivers for state or federal testing or accountability requirements for the 2025-2026 school year at this time. The NCDPI expectations are to move forward as scheduled.

- **ACT**

- This is a state-required
- The ACT is a state-required exam provided to **all 11th-grade students**
- Format: Online
- Date(s): March 24, 2026 - April 3, 2026
- Hanover Main Dates: March 24-March 26th
- **What is it and why is it important?** The ACT is a standardized, curriculum-based, multiple-choice achievement test that includes four areas: English, mathematics, reading, and science. The ACT assesses skills and knowledge that are important for success in college.
- **How are the results used?** The ACT score report provides information about a student's educational needs, extracurricular achievements, and educational plans. Results are used by high schools for advising and counseling students. Colleges and universities may use results to make decisions regarding admissions, scholarships and loans, and course placement. Check with individual colleges and universities for any ACT-specific requirements.

- EOC Exams will count as 20% of the student's final grade
- Exams given for: Math 1, Math 3, Biology, English 2
- **All students must take their exam in person, at school**
- **End of Semester Exams - Teacher Created (all courses that do not have an EOC or are not a CTE Course)**
 - Per NHCS Policy: "In courses that offer credit toward high school graduation, an examination shall be administered at the conclusion of each semester. End-of-Course examinations required by the State Board of Education shall be utilized in lieu of a teacher-developed examination and shall count as twenty percent (20%) of the final grade, if the exam score is available, with the exception of students following the Occupational Course of Study."
 - All courses that are not a CTE course or an EOC Course (EOC Courses = Math 1, Math 3, Biology, and English 2) will have a teacher-made assessment.
 - Teacher-made assessments will be provided: TBD
 - These assessments will be calculated as 20% of the student's final grade
 - Teachers will be releasing information concerning the specifics for their teacher-made assessment
