Thailand Entry Guidance

IMPORTANT: We at GEEO strive to provide accurate and up-to-date information. However, governments change visa rules. It is *your responsibility* to double-check information with the <u>US</u> <u>Department of State Bureau of Consular Affairs</u>.

Passport/Visa Requirements


Thailand <u>requires</u> visitors to have **at least six months of validity** remaining on their passports beyond their date of entry. Please check your passport's expiration date now and make sure there is sufficient validity remaining. Your passport must also contain at least one blank page for the entry/exit stamps.

U.S. citizens do not need to purchase a visa to visit Thailand, but all non-Thai nationals entering Thailand, regardless of travel mode (air, land, or sea), must complete the <u>Thailand Digital Arrival Card (TDAC)</u> online before arrival. This form is the electronic version of the traditional disembarkation card that visitors were previously required to complete upon arrival in Thailand.

Thailand Digital Arrival Card (TDAC)

The Thailand Digital Arrival Card must be submitted **within three days prior to arriving** in Thailand via the official government <u>TDAC site</u>.

If you are participating in a Vietnam and Cambodia trip (starting in Hanoi and ending in Bangkok), you will need to complete the TDAC form *while you are in Cambodia*. Your tour leader may complete a group submission for you.





Once you are within three days of your arrival in Thailand, you can submit the form on the TDAC site by clicking the "Arrival Card" button. You cannot complete the form earlier than three days prior to your arrival.

In the Personal Information section, enter your name, biographic details, and passport information. For Nationality/Citizenship, U.S. citizens should select "USA: American."

In the Trip & Accommodation Information section, provide the following information:

Arrival Information

- **Date of Arrival:** The date you intend to arrive in Thailand (can be no later than three days from today's date, based on the local time in Thailand).
 - If you are participating in a trip that does not begin in Thailand, reference your trip's webpage/itinerary to verify your arrival date in Thailand.
- Country/Territory where you Boarded: This is the point of departure from which you will travel to Thailand.
 - If you are participating in a trip that travels from Cambodia to Thailand, for example, you will select "Kingdom of Cambodia" for this field.
- Purpose of Travel: Select "Holiday."
- Mode of Travel: Select air, land, or sea as your method of transportation for arrival.
 - If you are participating in a Vietnam and Cambodia trip that ends in Thailand, you
 will be arriving by land. Select "car" as your mode of transport and enter "N/A" as
 the flight/vehicle number.

Departure Information

- **Date of Departure:** The date you intend to depart Thailand. Reference your program's webpage/itinerary to verify your departure date from Thailand, if necessary.
- **Mode of Travel (departure):** Select air, land, or sea as your method of transportation for departure.
 - If you are traveling from Thailand to Laos by land, select "car" as your mode of transport and enter "N/A" as the flight/vehicle number.

Accommodation Information

- You can find your starting hotel's information on your program's webpage and/or on the confirmation vouchers that you receive from GEEO after you complete Good to Go.
- Our Thailand programs generally start in Bangkok and use Hotel Royal Bangkok @
 Chinatown. If that is the case for your trip, you will select "Bangkok" as the province and
 "Samphanthawong" as both the District and Sub-District, and enter "409 421/4 Yaowarat
 Rd" as the address.

Complete the Health Declaration by entering all of the countries you stayed in during the two weeks prior to your arrival in Thailand. Review the accuracy of your information, enter your email address, agree to the terms & conditions, and click Submit.



TDAC Approval

Your Thailand Digital Arrival Card (TDAC) will be submitted immediately. You can download a copy of your TDAC confirmation, which is only valid for entry on the date you specified in your form. You will also receive an email with a copy of your confirmation letter.

The making of false or misleading travel declaration is an offence under Thailand law.

To update your arrival information (if necessary), you can return to the <u>TDAC website</u> or by scanning the QR code on your TDAC confirmation letter and email.

If you are flying to Thailand, your airline may request that you present your TDAC confirmation when you check in for your flight.

If you arrive in Thailand without having completed a TDAC form, you can do so while you are in line at the immigration checkpoint. The confirmation is immediate, so you can just show it from your phone. Just make sure you have filled it out by the time you arrive in front of the immigration officer.
