

## VISIT FLORIDA Teacher Appreciation Contest Rules

These contest rules are specific to the above contest conducted by Audacy Pennsylvania d/b/a WBEB-FM (the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this Contest as well. A copy of these specific contest rules and the Station’s general contest rules are available at the Station’s studio at 2400 Market Street, 4<sup>th</sup> Floor, Philadelphia, PA 19103 during regular business hours and on the Station’s website at <https://www.audacy.com/b101philly/contests>. To the extent that the Station’s general contest rules differ from these rules, these rules will govern and control with respect to this contest.

### How to Enter

---

1. No purchase or payment of any kind is necessary to enter or win the **VISIT FLORIDA Teacher Appreciation** contest (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. Eligible Nominees must both be twenty-five (25) years of age or older and legally reside in Pennsylvania, New Jersey or Delaware as of the date of entry in this Contest (each a “**Nominee**”).
  - a. Individuals may make Nominations (each, a “**Nominator**”) starting at 12:00am (ET) on September 1, 2025 and ending at 11:59pm (ET) on December 31, 2025 by means of submissions to the Station by completing the form on the Station’s website by clicking on the “**VISIT FLORIDA Teacher Appreciation**” page and submit all of the following materials:
    - i. Nominator’s contact information including Nominator’s full name, address of legal residence, phone number (including area code), date of birth, and e-mail address; and
    - ii. The name, address, age, and telephone number (including area code) and school of the Nominee that you are nominating in this Contest (each a “**Nomination**”).
    1. **Nominators may not nominate themselves.**
    2. **Nominators are not eligible to win or receive a prize in this Contest.**
  - b. IT IS THE NOMINATOR’S RESPONSIBILITY PRIOR TO ENTERING THIS CONTEST TO OBTAIN THE CONSENT OF THE NOMINEE TO STATION READING/POSTING THE NOMINATOR’S NOMINATION WITH RESPECT TO THE NOMINEE’S NAME AND OR OTHER PERSONAL INFORMATION ABOUT THE NOMINEE. BY ENTERING THIS CONTEST, NOMINATORS AGREE TO INDEMNIFY AND HOLD HARMLESS STATION AND ITS AFFILIATED COMPANIES AND EMPLOYEES FROM AND AGAINST ANY CLAIM BY ANY PERSONS RELATING TO THE CONTENT OF THE NOMINATION SUBMITTED BY THE NOMINATOR.
  - c. As part of the entry process, Nominator may be provided with an opportunity to opt-in to receive solicitations from, and/or to become a member/participate in clubs of (*i.e., email clubs, text clubs, and rewards programs*), the Participating Stations; provided, however, agreeing to receive such solicitations and/or accepting such membership is not a condition of entry into this Contest and will not increase your chances of winning.
3. Failure to submit all of the above items in one submission/Nomination will result in disqualification.
4. WHETHER OR NOT SELECTED AS A WINNER, ALL ENTRIES BECOME THE SOLE PROPERTY OF STATION AND MAY BE USED BY STATION (OR ITS SPONSORS) IN ANY MEDIUM IT DEEMS DESIRABLE NOW OR IN THE FUTURE WITHOUT ANY COMPENSATION TO THE NOMINATOR OR NOMINEE.

### How to Win

5. Upon verification of eligibility and compliance with these Contest rules, up to four (4) entries will be selected as “**Winners**” in this Contest as described below:
  - a. At approximately 12:00pm (ET) on October 1, 2025, one (1) Winner will be randomly selected from among all of the entries received as of 11:59pm (ET) on September 30, 2025 to receive one (1) Prize in this Contest (*as described in Section 9 below*), subject to verification and compliance with the Contest rules. Entries not selected will be retained and included in all subsequent drawings in this Contest.



- b. At approximately 12:00pm (ET) on November 1, 2025, one (1) Winner will be randomly selected from among all remaining entries received as of 11:59pm (ET) on October 31, 2025 to receive one (1) Prize in this Contest (*as described in Section 9 below*), subject to verification and compliance with the Contest rules. Entries not selected will be retained and included in all subsequent drawings in this Contest.
  - c. At approximately 12:00pm (ET) on December 1, 2025, one (1) Winner will be randomly selected from among all remaining entries received as of 11:59pm (ET) on November 30, 2025 to receive one (1) Prize in this Contest (*as described in Section 9 below*), subject to verification and compliance with the Contest rules. Entries not selected will be retained and included in all subsequent drawings in this Contest.
  - d. At approximately 12:00pm (ET) on January 2, 2026, one (1) Winner will be randomly selected from among all remaining entries received as of 11:59pm (ET) on December 31, 2025 to receive one (1) Prize in this Contest (*as described in Section 9 below*), subject to verification and compliance with the Contest rules.
  - e. The Station will notify the Winner(s) by means of the phone number or email address provided to the Station at the time the Nominee entered the Contest.
  - f. A Nominee can only be a Winner one (1) time in this Contest.
6. Odds of winning the Prize in this Contest shall depend upon the number of entries received prior to each random drawing.
  7. PRIZES WILL BE AWARDED TO THE SELECTED NOMINEES WHO WILL BE THE ONLY PERSONS ACKNOWLEDGED AS WINNERS IN THIS CONTESTS. THE NOMINEES WILL BE REQUIRED TO COMPLETE THE NECESSARY FORMS REQUIRED BY STATION (INCLUDING, WITHOUT LIMITATION, ACKNOWLEDGEMENT OF RESPONSIBILITY FOR TAXES, PROOF OF AGE AND RESIDENCY) PRIOR TO RECEIVING THE PRIZE. WINNERS MUST RETURN ALL DOCUMENTS SENT TO THEM AND REQUIRED TO BE SIGNED BY THE STATION WITHIN 7 DAYS OF RECEIPT. PRIZES WILL BE SHIPPED BY US PRIORITY MAIL WITH IN 4-6 WEEKS AFTER STATION RECEIVES ALL OF THE REQUIRED PAPERWORK BACK. IN THE EVENT OF A FAILURE BY A NOMINEE TO ACCEPT THE PRIZE, TO COLLECT THE PRIZE, OR TO COMPLETE THE FORMS BY THE DEADLINE REQUIRED BY STATION, THE PRIZE WILL NOT BE AWARDED UNLESS OTHERWISE DECIDED BY THE STATION IN ITS SOLE DISCRETION ON A CASE BY CASE BASIS. THE STATION IS NOT OBLIGATED TO SELECT A REPLACEMENT NOMINEE (BUT RESERVES THE RIGHT TO DO SO IN ITS SOLE DISCRETION, TIME PERMITTING).
  8. Station has no obligation to notify a Nominator that their Nominee was selected as a winner. Station has the absolute and irrevocable right to notify the Nominee of the name of the Nominator(s) who nominated him/her.

## Prizes

9. The four (4) verified Winners will each receive the following **"Prize"**: one (1) VISIT FLORIDA Vacation Package for two (2) people to Fort Lauderdale, FL. Each vacation package includes: (i) three (3) consecutive night (double occupancy) stay at Fort Lauderdale Marriott Harbor Beach Resort & Spa; (ii) round-trip coach class airline tickets for one (1) winner and up to one (1) guest to Fort Lauderdale-Hollywood International Airport; (iii) one (1) midsize rental vehicle for four (4) consecutive days; (iv) two (2) all-day passes to ride aboard Fort Lauderdale Water Taxi; (v) two (2) speed boat cruises aboard the Sea Rocket Fort Lauderdale; and (vi) two (2) sightseeing cruise tickets aboard Jungle Queen Riverboats. Travel may be taken through **July 31, 2027**. Blackout dates may apply. Redemption instructions will accompany all certificates. The minimum age to book all elements of this prize package is 25. Prizes are non-transferable, cannot be sold or gifted, may not be redeemed for cash, and will not be replaced if lost or stolen. Extensions to expiration dates will not be granted. The entry process may require Entrants to login to, or to create, a free account with the third party provider of a software platform used by the Station for such Contest(s) ("**Software Provider**"), by going to the Website, clicking on the Contest entry link, and completing and submitting the online registration form with all required information.
- a. Limit one (1) account with the Software Provider per email address.
  - b. Software Provider is not a sponsor of this Contest, but Entrants may be required, as part of the entry process, to agree and consent to the Software Provider's terms of service and/or privacy policy, both of which will be available via a link during the entry or account registration process (collectively, the "**Software Provider Policies**").
  - c. If the Entrant elects to have their entry form pre-loaded or pre-populated with information from the Entrant's Facebook, Twitter, Google, or LinkedIn profiles, such Entrant authorizes the Software Provider and the Station to access, utilize and/or pre-load to such entry form, applicable portions of Entrant's profile information from such account.
  - d. While agreement to the Software Provider Policies may be required in order to enter the Contest, the Software Provider Policies are not a part of these Contest Rules but are a separate agreement between the Entrant and Software Provider. In the event of any conflict between the Software Provider Policies and the Rules, the Rules will govern.
  - e. Station is not responsible for any error or technical malfunctions associated with the Software Provider site that may affect any Entrant's ability to enter, to win, or to be properly considered in the Contest, regardless of the cause. In the event of a malfunction associated with the Software Provider site that the Station in its sole and absolute discretion deems to materially and adversely affect the Contest, the Station reserves the right to (1) suspend the Contest; (2) terminate the Contest without a Winner; (3) terminate the Contest and select a Winner early; (4) provide alternative means of entry; and/or make any other changes to the Contest that the Station deems appropriate under the circumstances. Any such changes, terminations or suspensions will be published on the Contest Rules Page, and in the Station's sole and absolute discretion, may also be announced on-air, published elsewhere on the Website, and/or published on social media.
  - f. Employees of Software Provider and its affiliates, their respective parents, affiliates, subsidiaries, advertising sponsors and promotional agencies, and the immediate family members of each are not eligible to win in this Contest.
