WHAT I DRAW

- Furries, humans, feral; anything
- NSFW (including short comics)
- Chibi/cute/kawaii and the opposite
- Gore (not my strong suit, though)

WHAT I DON'T DRAW

- Drugs related
- Extreme armor
- Extreme detailed background
- Traditional





- You need a reference sheet or detailed written description to commission me. Unless you commission a custom character design and you want me to make it up as I go...
- I have school, and jobs, and... life... Please be patient and don't rush me. Feel free to shoot me a message if it's been, like, a month and I haven't sent you an update. I will send WIPs as I go.
- I have the right to draw personal art or take a break while I have a commission or trade pending, but I haven't forgotten your commission.
- All my artwork is copyrighted, I put my watermark on every drawing. Keep the
 watermark on; I promise it's not big and distracting. If you want a version without my
 watermark you can ask, but it's NOT allowed for public use, only personal. Please
 respect me as an artist.
- You (the client, no one else unless you get permission) are allowed to re-post the
 commission or use it as your profile photo on your page(for example: on your
 character/fursona account), but it must be credited including the link or username of
 my <u>FurAffinity</u> (rabiosarat).
- I will send a WIP sketch first, then you send me payment. I DO NOT COMPLETE ARTWORK BEFORE RECEIVING PAYMENT. I have had bad experiences before.
- You are NOT allowed to recolor or trace my work.
- If you already accepted the WIP of your commission, and then you ask for a change
 when the work is already finished, you have two options: pay more (depending on what
 you want to change) OR just keep the drawing. Your reference and your commission
 idea needs to be <u>clear</u>. The only time you can request <u>free</u> changes is during the WIP
 stage.
- I have the right to cancel a commission without explanation, though, I probably will explain myself. Don't push if I don't.



- <u>Do not delete my watermark.</u> That's a big one. It won't be big and distracting, so
 please keep it on there.
- Always credit me wherever you post my work. Credit me at FurAffinity (rabiosarat).
- You can make small changes to the adoptable once you buy it, for example: add piercings, tattoos, scars, etc.
- You can change the gender and name of the character once you buy it.
- Once you buy the character, you can do whatever you want with it. This means you can
 make NSFW art of it, roleplay, etc. You <u>can't</u> claim the design as your own.
- You are **NOT** allowed to claim the design of the adoptable as your own even if you bought it.



- I send PayPal invoices. I need your PayPal email to send you the invoice.
- Refunds on emergency commissions or emergency adoptables are not available.
- I can only refund the payment within 48 hours. If 48 hours passes after you send the payment, a refund is no longer available.
- Send payment promptly. If you take longer than 72 hours, I reserve the right to cancel your request. For custom commissions you have 72 hours after I send the WIP sketch.
- Refunds are not available after I have finished your commission/request. Don't ask.
