Memo No. A-34013/01/2010-DE (Pt.I) dated 30/06/2011 (copy attached).

Shri Bikash Roy was initially allotted to Jharkhand Circle and S/Shri Jagannath Chatterjee and Sanjeev Roy were allotted to UP Circle vide above captioned memo and subsequently re-allotted to West Bengal Circle vide Directorate Memo No. A-34013/01/2010-DE (Pt.I) dated 09/08/2011 (copy attached). These surplus qualified IP candidates were not appointed in Inspector Posts cadre in West Bengal Circle due CAT case filed by some candidates under OA No. 845/2011 dated 30/09/2011 at Hon'ble CAT West Bengal Bench. It is also to mention here that, all other surplus candidates of Inspector Posts Examination 2009 and even qualified candidates of Inspector Posts Examination 2011 have already appointed in the respective circles.

It is to further state that, the above named three candidates vide their enclosed applications having shown their willingness to join to their originally allotted circles or any neighboring circle where sufficient vacancies are still available.

In view of the above lines, it is requested to kindly look into the matter personally and arrange to issue necessary instructions to CPMsG Jharkhand and Uttar Pradesh Circles to issue their posing orders in Inspector Posts Cadre and to CPMG West Bengal Circle to issue relief orders at the earliest.
