- Certify that all information in the proposal and all supporting documentation are authentic and accurate.
- Certify understanding and agreement to Fani SRL' prohibitions against fraud, bribery and kickbacks.

Section 1: Instructions to Offerors

1. Introduction:

Fani SRL intends to purchase a packing line for fresh plums and other fresh fruits. The purpose of this RFQ is to solicit quotations for this equipment and associated services.

Offerors are responsible for ensuring that their offers are received by Fani SRL in accordance with the instructions, terms, and conditions described in this RFQ. Failure to adhere with instructions described in this RFQ may lead to disqualification of an offer from consideration.

- 2. <u>Offer Deadline and Protocol</u>: Offers must be received no later than **17:00** local Chisinau time on March **11, 2022** by e-mail to <u>office@fani.md</u>
- 3. **Questions**: Questions regarding the technical or administrative requirements of this RFQ may be submitted no later than **17:00** local Chisinau time on **March 9, 2022** by email to office@fani.md. Questions must be submitted in writing; phone calls will not be accepted. Questions and requests for clarification and the responses thereto that Fani SRL believes may be of interest to other offerors will be circulated to all RFQ recipients who have indicated an interest in bidding.

Only the written answers issued by Fani SRL will be considered official and carry weight in the RFQ process and subsequent evaluation. Any verbal information received from employees of Fani SRL or any other entity should not be considered as an official response to any questions regarding this RFQ.

4. **Specifications**: Section 3 contains the technical specifications of the required items. All commodities offered in response to this RFQ must be new and unused.

Please note that, unless otherwise indicated, stated brand names or models are for illustrative description only. An equivalent substitute, as determined by the specifications, is acceptable.

5. Quotations: Quotations in response to this RFQ must be priced on a fixed-price, all-inclusive basis, including delivery to Fani's facility and all other costs. Pricing must be presented in <u>EUR</u>. Offers must remain valid for not less than thirty (30) calendar days after the offer deadline. Offerors are requested to provide quotations on their official quotation format or letterhead. In the event this is not possible, offerors may complete the table in Section 3.

In addition, offerors responding to this RFQ are requested to submit the following:

- Copy of their official registration and business license.
- Contact information from three former customers who have bought similar products from the offeror.
- 6. <u>Delivery</u>: The delivery location for the items described in this RFQ is <u>Miclesti village</u>, <u>Criuleni district</u>, <u>Republic of Moldova</u>. As part of its response to this RFQ, each offeror is expected to provide an estimate (in calendar days) of the delivery timeframe (after receipt of order) but not later than <u>April 30</u>, <u>2022</u>. The delivery estimate presented in an offer in response to this RFQ must be upheld in the performance of any resulting contract.
- 7. <u>Source/Nationality/Manufacture</u>: Offerors may <u>not</u> offer or supply any commodities or services that are manufactured or assembled in, shipped from, transported through, or otherwise involving any of the following countries: Cuba, Iran, North Korea, Syria.

- 8. <u>Warranty</u>: The warranty coverage must be valid on all commodities for a minimum of twelve (12) months after delivery, installation and acceptance of the commodities, unless otherwise specified in the technical specifications. At the time that any commodity is transferred to another entity, all rights to warranty support and service shall be transferred with the commodity to that entity's end-user.
- 9. <u>Taxes and VAT</u>: The agreement under which this procurement is made does not permit the financing of any taxes, VAT, tariffs, duties, or other levies imposed by any laws in effect in the Republic of Moldova. No such taxes, VAT, charges, tariffs, duties or levies will be paid under a purchase order resulting from this RFQ.
- 10. <u>Eligibility</u>: By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, or otherwise considered ineligible for an award by the Republic of Moldova or any other country's Government. Fani SRL will not award a contract to any firm that is debarred, suspended, or considered to be ineligible by the Republic of Moldova or any other country's Government.
- 11. <u>Evaluation and Award</u>: The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and is determined via a trade-off analysis to be the best value based on application of the following evaluation criteria. The relative importance of each individual criterion is indicated by the number of points below:
 - *Price* **30 points:** The overall cost presented in the offer.
 - *Technical* **45 points:** Responsiveness to the technical specifications and correspondence to the technical requirements of the offered products. How well does the offer meet or exceed the technical specifications?
 - Delivery and installation **15 points:** Delivery and installation must be met by the required date of August 20, 2019, or sooner if possible. In the event that no offeror is able to meet this deadline, the shortest timeline after April 30, 2022 will be considered favorably.
 - After sales service **10 points**: The ability to provide timely and complete after sale service, preferably by an entity located in the Republic of Moldova or neighboring countries. The quality of any warranty services provided.

Please note that if there are significant deficiencies regarding responsiveness to the requirements of this RFQ, an offer may be deemed "non-responsive" and thereby disqualified from consideration. Fani SRL reserves the right to waive immaterial deficiencies at its discretion.

Best-offer quotations are requested. It is anticipated that award will be made solely on the basis of these original quotations. However, Fani SRL reserves the right to conduct any of the following:

- Fani SRL may conduct negotiations with and/or request clarifications from any offeror prior to award.
- While preference will be given to offerors who can address the full technical requirements of this RFQ, Fani SRL may issue a partial award or split the award among various suppliers, if in the best interest of Fani SRL.
- Fani SRL may cancel this RFQ at any time.

Please note that in submitting a response to this RFQ, the offeror agrees that any protest hereunder must be presented—in writing with full explanations—to Fani SRL for consideration. Fani SRL, at its sole discretion, will make a final decision on the protest for this procurement.

12. <u>Terms and Conditions</u>: This is a Request for Quotations only. Issuance of this RFQ does not in any way obligate Fani SRL to make an award or pay for costs incurred by potential offerors in the preparation and submission of an offer.

This solicitation is subject to Fani SRL standard terms and conditions. Any resultant award will be governed by these terms and conditions. Please note the following terms and conditions will apply:

- (a) Payment will only be issued to the entity submitting the offer in response to this RFQ and identified in the resulting award; payment will not be issued to a third party.
- (b) Any award resulting from this RFQ will be firm fixed price, in the form of a purchase order.
- (c) No commodities or services may be supplied that are manufactured or assembled in, shipped from, transported through, or otherwise involving any of the following countries: Cuba, Iran, North Korea, Syria.
- (d) The title to any goods supplied under any award resulting from this RFQ shall pass to Fani SRL following delivery and acceptance of the goods by Fani SRL. Risk of loss, injury, or destruction of the goods shall be borne by the offeror until title passes to Fani SRL.
