## 進出口件禁止/限制寄遞物品

- 武器、模擬武器、彈藥、管制器具及其仿製品
  - 如:剪刀、槍支、子彈、炮彈、手榴彈、地雷、炸彈等
- 危險或易燃燒性物品、易爆炸性物品
  - 如:香水、酒精、香薰、指甲油、油漆、汽油、機油、樟腦油、松節油、天拿水、膠水、雷管、炸藥、火藥、鞭炮、等
- 氧化劑和過氧化物
- 各種藥品
- 毒品及吸毒工具、非正當用途麻醉藥品和精神藥品、非正當用途的易制毒化學品、毒性物質
- 生化製品、傳染性、感染性物質
  - 如:炭疽、危險性病菌、害蟲及其它有害生物的支、植物及其產品、醫用廢棄物等
- 腐蝕性物質、放射性物質
  - 如:鉈、氰化物、砒霜等
- 偽造或者變造的貨幣、有價證券、證件、公章等非法偽造物品
- 貨幣和有價證券
- 侵犯智慧財產權和假冒偽劣物品
  - 如:假冒商品、盜版製品和侵權產品
- 動植物尤其各類瀕危野生動物植物及其製品
- 有礙人畜健康的、來自疫區的以及其他能傳播疾病的食品、藥品或者其他物
- 煙草和煙草製品、酒精類飲品
- 貴重物品
  - 如:藝術品、古董、寶石以及黃金等貴重金屬
- 含食物
- 其他法律法規的違禁品
- 航空安全管制物品
- 任何未提供寄件人和收件人的詳細聯絡資訊的包裹
- 不恰當地描述、分類或包裝的物品
- 產品本身或包裝特性可能危及運輸工具及人員安全的物品
- 手提電腦及電腦\*

遵守始發地國家/地區當前適用的法律法規及政府規定是寄件人的義務。各個國家/地區規定禁止或限制寄遞的物品不盡相同,除以上禁寄/限寄物品標準外,建議寄件人還需參考物品寄遞目的地國家/地區的進出口禁寄/限寄物品列表。

## **Prohibited or Restricted Items for Export and Import Delivery Parcels**

- Arms, simulation weapons, ammunition, controlled knives, and explosive articles.
  - Such as scissors, guns, bullets, shells, grenades, mines, bombs, etc.
- Dangerous or inflammable or explosive articles
  - Such as perfume, alcohol, aromatherapy, nail polish, paint, gasoline, motor oil, camphor oil, turpentine, glue, detonators, explosives, gunpowder, firecrackers, etc.
- Oxidizing agents and peroxides.
- Medicine
- Narcotic drugs and drug taking tools, stupefacient and psychoactive drugs that are in improper use and precursor chemicals and toxic substances that are in improper use.
- Biochemical, epidemic and infectious materials.
  - Such as anthrax, dangerous germs, pests and other harmful organisms, medical waste, etc.
- Radioactive substances and radioactive substances.
  - Such as thallium, cyanide, arsenic, etc.
- Illegal counterfeit products such as counterfeit or altered currency, marketable securities, certificates, and official seals.
- Currency and negotiable securities.
- Articles that infringe intellectual property rights, and counterfeit and shoddy products.
  - Such as counterfeit, pirated and infringing products, etc.
- Animals and plants, especially those endangered wild animals and plants as well as their products.
- Food, drugs or other articles that are hazardous to human and animal health and may spread disease from an infected area.
- Cigarettes and tobacco, tobacco products, and liquor.
- Valuables.

- Such as artworks, antiques, gems, and precious metals including gold.
- Food items
- Other articles or substances which are capable of posing a hazard to health, safety, property or the environment and so are prohibited from mailing under other laws and regulations.
- Laptops & computers\*

It is the obligation of the shipper to obey the applicable laws, regulations, and government regulations of the origin and destination countries/regions, and articles prohibited or restricted from mailing in different countries and regions may vary. Therefore, in addition to the above standards of articles prohibited/restricted for mailing, the shipper is suggested to refer to the list of prohibited/restricted articles from import/export specified by the origin and destination countries or regions.

Laptops & computers belong to the category of restricted Items and merchant is required to provide Material Safety Data Sheet (MSDS) with the items for export purpose
