

PD Fund Updated Operating Procedures



Our Collective Agreement

Article 27 Evaluation / Peer **Coaching and Mentoring**

27.01 Only supervisory officers and elementary principals and vice-principals shall evaluate a teacher's competence using an evaluation policy/procedure developed in consultation with the Local. No member of the Union shall be required or requested to evaluate a teacher's competence.

27.02 The Board and the Local agree that Teacher Performance Appraisal (New Teacher Induction Program (NTIP), Performance **Appraisal for Experienced Teachers** (PAET), shall be conducted in accordance with the Education Act, relevant legislation, and in accordance with the Ministry of Education's technical manuals.

27.03 Except as otherwise required in the Education Act or in regulation, no teacher shall be required to act as a peer coach or mentor to another teacher. No information obtained from a coach or mentor, as part of their coaching or mentoring, shall be used in the assessment or evaluation of any teacher. p. 197

Note: this means that temporary vice principals cannot evaluate teachers formally or informally. Coaches and peer mentors cannot provide evaluative comments to administrators on the teachers they are working with or mentoring.
