Abstract

Describe an abstract in one concise and clear way, with no more than 250 characters, and language English and Indonesia. The abstract should not include an introduction or conclusion of the article; and instead, it is encouraged to include several key points: 1. Main questions and context of the discussion; 2. Role of the study; 3. Results of the data; and 4. How the article discussed. It is still possible to convey the things that are significant and contribute to the research as long as the words do not exceed the number as mentioned beforehand. It is also necessary to avoid the footnotes and references.

Keywords: *Mention 3-5 specific words or phrases about your research variables. Keywords are designed to facilitate the retrieval of articles by search engines, so do not use general terms. This will be useful for indexing purposes.*

Abstrak

INTRODUCTION

The body of paper must be elaborated between 6500 - 7.000 words (maximum) including abstract, references and footnotes, written in font: Calisto MT, size: 12, line spacing: multiple (1.5). Moreover, **the author(s) are required to use this template file (NOT creating new file)** in order to avoid mismatch in the whole page layout (paper size, margins, etc). Papers should be formatted for **A4** paper.

Introduction should contain the description of paper focus and main arguments of the authors going to present in the whole body of the paper. Authors may use the sub-title "Introduction" or the other words of expressions as long as the substance is to introduce the readers the purpose of the paper.

It is expected that authors will submit carefully written and proofread materials. Careful checking for spelling and grammatical errors should be performed. The whole body of the paper should clearly describe the **introduction, discussion , and conclusion.**

DISCUSSION

Discussions may include of theoretical frameworks, explanation of research methods, explanation of research objects (case study), main research findings and analysis (discussions). There is no limitation of the number of sub-titles in the body text. Authors may modify the naming the sub-titles as long as it supports authors' argumentation.

The subheading of The Analysis and Results

Following the main headings should be bold.

Sub-Subheading of the Analysis and Results

Following subheadings should be bold and italic.

Tables

All tables should be numbered with Arabic numerals and should be of a size adequate for clear understanding and placed in the text where appropriate. Every table should have a caption. Headings should be placed above tables, left justified. Only horizontal lines should be used within a table, to distinguish the column headings from the body of the table, and immediately above and below the table. Tables must be embedded into the text and not supplied separately. Below is an example which the authors may find useful.

Footnotes

Footnotes may be used to put some additional explanations if necessary. Necessary footnotes should be denoted in the text by consecutive superscript letters¹¹. The footnotes should be typed single spaced, and in smaller type size (8 pt), at the foot of the page in which they are mentioned, and separated from the main text by a one line space extending at the foot of the column.

CONCLUSION

The conclusion contains a description that should answer the objectives of the research. Provide a clear and concise conclusion. Do not repeat the Abstract

or describe the results of the research. Give a clear explanation regarding the possible application and suggestions related to the research findings.

REFERENCES

The minimum references are 15, and it must be based on 80% journals and 20% of books published in the last ten years. The citation style of the manuscript should be written in APA (American Psychological Association) both in the body text and references. Cite only items that you have read and on footnotes. Please use Reference Manager Applications like EndNote, Mendeley, Zotero, etc. All publications cited in the text should be included as a list of Bibliography, arranged alphabetically by author.

BIBLIOGRAPHY

Bibliography should be written in alphabetical order following the examples below, for book (see Axford), journal (see Arditi), seminar proceeding (see Andreassen) and book chapter (see Geertz).
