#### **Old Business**

Debbie: Met with Truist contact about getting Zell (automatic payment for Truist) as well as debit card tied to Intergroup account. Cliff will receive debit card in the mail; Zell setup has to be done through Cliff's sign-in to our Truist account. Debbie will walk Cliff through the procedure. They plan to get this done on Saturday 1/18.

Status of Claudia providing a Zoom tutorial for groups to know how to open up group-named checking accounts with no service charges not addressed this meeting because Secretary overlooked this item on the agenda.

Intergroup service positions on the Literature Committee are still vacant. Chris suggested that we encourage a couple of people to step up for these service positions so that the idea doesn't overwhelm a single individual.

#### **New Business**

Laura proposed that Intergroup sponsor a workshop in the spring. Topics were suggested including that of Sponsorship. A lot of time was spent discussing ACA sponsorship in general with controversy arising over whether any ACA should sponsor another ACA through the ACA Steps if that person has not done the ACA Steps themselves. BRB delineates 4 different types of sponsorship: Traditional, Co-Sponsor, Temporary and Long-Distance. There was disagreement as to whether individuals in ACA should co-sponsor each other through the Steps. The point was also made that, even though an individual has worked the 12 Steps in another 12-Step program, that person was not equipped to sponsor someone through the ACA Steps if they themselves have not done the ACA steps - those persons should not think that their experience with the Steps through another fellowship can be imposed on the ACA 12 Steps, the aim of which is distinctly different from any other 12-Step program. The point was made that we really must encourage those who have completed the ACA Steps to sponsor others through the Stepss. Chris made the point that there are some ACAs who will only do a 5th Step with their therapist. Marty mentioned that there's a WSO tri-fold entitled "To Therapists" that he will purchase and review. It may be a good thing to include in the Public Outreach information distributed.

It was agreed that shooting for an Intergroup-sponsored workshop in May would be good. We will return to next month's Intergroup meeting with more detailed ideas about what topic(s) the workshop will address.
