

Privacy Policy:

Introduction

- a. This privacy policy sets out the manner in which The MKF (“we”, “us”, “our”) collects, uses, stores and discloses the information collected from users (“you”, “your”) of Super Ball.
- b. By using Super Ball, you acknowledge and agree to the terms of this privacy policy.

Collection of Information

- a. We may collect the following information from you:
 - i. Personal information such as your name, email address, and phone number;
 - ii. Information generated through the use of Super Ball, including your pronunciation recordings and proficiency level feedback.
 - iii. The information we collect is used to provide the services offered through Super Ball and to improve the app.

Use of Information

- a. We may use the information collected from you for the following purposes:
 - i. To provide the services offered through Super Ball;
 - ii. To improve the app and develop new features;
 - iii. To send you updates and news related to Super Ball;
 - iv. To comply with legal requirements.

Storage of Information

- a. The information collected from you is stored on secure servers located in Hong Kong SAR.
- b. We take reasonable steps to protect the information we collect from unauthorized access, use, or disclosure.

Disclosure of Information

- a. We may disclose the information we collect from you to third parties in the following circumstances:
 - i. With your consent;
 - ii. To comply with legal requirements;
 - iii. To protect the rights and safety of The MKF and others.

- You represent and warrant that you own or have the necessary rights to the content you provide through Super Ball.

- Super Ball and the services provided through the app are provided on an "as is" and "as available" basis.
- The MKF makes no representations or warranties of any kind, express or implied, as to the operation of Super Ball or the accuracy, completeness, or reliability of any content generated through the app.
