

Extended Terms of Service Agreement

This document presents the Extended Terms of Service Agreement for the Eevee Expo. It outlines your participation in the Expo, including asset usage, content guidelines, and applicant responsibilities. By applying, you are agreeing to these terms. We encourage a careful review of them.

Figure 1.0 - Usage of Submitted Assets

1.1 - Usage of Trailers & Logos for Promotional Purposes

Upon application to the Eevee Expo, I hereby grant permission to the Eevee Expo Event team (hereinafter referred to as “the Eevee Expo team” or “the team”) to utilize and disseminate my project’s logo (excluding any other assets submitted with the application form) and my Eevee Expo trailer on social media platforms such as Discord or Twitter/X for promotional purposes, irrespective of full dissociation or violation of other terms.

1.2 - Usage of Trailers and Interviews for the Eevee Expo Presentation Video

Upon application to the Eevee Expo, I hereby grant permission to the Eevee Expo team to utilize, modify, and disseminate my Eevee Expo trailer within the context of the Eevee Expo presentation and/or my recorded interview session, unless a full dissociation occurs, the process of which is detailed in Figure 4.2.

Figure 2.0 - Submission, Trailer, and Interview Contents

2.1 - Prohibited Content from Applications

Upon my application to the Eevee Expo, I acknowledge that the Eevee Expo team reserves the right to reject my application or rescind my candidacy if my project contains content which is deemed contradictory to the terms of service or the values of the Eevee Expo team, such as maliciously discriminatory or defamatory content, overly sexual themes, plagiarized assets, AI-generated content, etc. Furthermore, I agree that the project I submit as part of the Eevee Expo application process is in a playable state (no official release required) at the time of the Eevee Expo application deadline.

2.2 - Prohibited Content from Submitted Trailers/Interviews

Upon application to the Eevee Expo, I agree to exclude major profanity, NSFW content and visuals that could trigger seizures from my submitted trailer and/or interview or be required to make modifications.

2.3 - Moderated Content

Upon application to the Eevee Expo, I acknowledge that the Eevee Expo team reserves the right to place a content warning before my trailer in the context of the Eevee Expo presentation if it contains content deemed unsuitable for individuals under 13 years of age.

2.4 - Permission from First Parties Concerning Transformative Works

Upon application to the Eevee Expo, I agree that if my project is a remake, spinoff, prequel, sequel or alternate universe of an existing fangame of which I am not the original creator, I must provide explicit written permission from the original creator to transform their work to a member of the Eevee Expo team before meeting the trailer submission deadline.

2.5 - Prohibited Submission of Pre-Made Trailers

Upon application to the Eevee Expo, I agree that my trailer, which would be submitted for exhibition should I be chosen for the Eevee Expo roster, has not been conceived in advance in any way and is not publicly viewable in any form until the sanctions disclosed in Figure 3.2 have been met.

2.6 - Follow-Up Responsibility

Upon application to the Eevee Expo, I acknowledge that if my application is accepted, it is my responsibility to formally reply to the Eevee Expo team member responsible for following up on my application to confirm my candidacy in the Eevee Expo presentation. In addition, I agree that **a member of my team must accept the Discord invitation linked within my official candidacy confirmation message and join the appropriate Event Discord server** in order to establish a direct line of communication with the Eevee Expo Team. Failure to respond and join the Discord Server within 14 days of acceptance will result in forfeiture of my candidacy.

Figure 3.0 - Confidentiality & Exclusivity

3.1 - Confidentiality of Candidacy & Trailer Contents

Upon application to the Eevee Expo, I commit to maintaining the confidentiality of non-public information pertaining to my own and other applicants' Eevee Expo presentation candidacy or Eevee Expo trailer, unless formal written consent is obtained from a member of the Eevee Expo team.

3.2 - Temporary Exclusivity Clause

Upon application to the Eevee Expo, I commit to abstaining from disseminating my Eevee Expo trailer and/or interview in a standalone, non-transformative format on any social media platform prior to or less than 24 hours after the airing of the Eevee Expo presentation it was intended for.

3.3 - Applicant Responsibility

Upon application to the Eevee Expo, I acknowledge that it is my responsibility to inform my development team members of, and ensure compliance with, the Eevee Expo Terms of Service. Violations of the Terms of Service committed by team members (current and future) will be subject to enforcement measures, irrespective of tenure or awareness.

Figure 4.0 - Deadlines & Dissociation

4.1 - Deadline Notice

Upon application to the Eevee Expo, I commit to notifying the Eevee Expo team of any setbacks that could prevent me from meeting the Eevee Expo trailer submission deadline at least one week in advance.

4.2 - Full Dissociation

Should I wish to withdraw my participation from the Eevee Expo after having submitted an application, I commit to notifying the Eevee Expo team via direct messages at least two weeks prior to the Eevee Expo trailer submission deadline.

4.3 - Cancellation of Candidacy

Upon application to the Eevee Expo, I acknowledge that the Eevee Expo team reserves the right to rescind my candidacy if events involving me or any of my team member's are deemed contradictory to the values upheld by the Eevee Expo team, or if I become banned from the Eevee Expo discord server or forums.

4.4 - Forum Thread Deadline

Upon application to the Eevee Expo, I agree that a thread for my project must be posted or pending approval on the Eevee Expo forums at the date of the trailer submission deadline.

Figure 5.0 - Consequences of Violating the Terms of Service

Failure to comply with any of the preceding agreements may result in a range of penalties (applied on a case-by-case basis and at the discretion of the Eevee Expo team), which may

include but are not limited to:

- Temporary or permanent exclusion from future Eevee Expo presentations, trailer submissions, interviews, or other events.
- Lower priority when applying for future Eevee Expo presentations.
- Other punishments when deemed appropriate, at the discretion of the team.
