So we're going to go through some of the bills that Cassie and Kristen worked on this week, and then we have a handful of new ones to get to too.

Cass, why don't you take it?

Away. OK, so some updates that I have our House Bill 386, which is continuous Medicaid eligibility.

Passed the House floor 53 to 47, it is being heard in the appropriation. The House Appropriations Committee on Tuesday, February 25th at 20 clock in Room 102. So this bill would be great for continuous Medicaid eligibility.

Seems to be well accepted and so we'll just keep cheering that one on and we will monitor.

Turret House Bill 395 was the bad.

00:02:16 Cassie

We talked about, which is generally revised voting laws related to individuals of unsound mind.

So that passed the House floor 57 to 43, which was disappointing.

Then on the third reading, it passed 54 to 45.

So a couple people.

Shifted and now it's being transmitted to the.

So I do know that disability rights Montana is working really hard on trying to get to the different senators and those who are making decisions on this bill.

Yesterday we attended a press conference at disability Rights.

They had a sheet included on that and so we can share that information out with everyone.

This is really about protecting voting rights of all people.

It it astounds me that this is where we're at with this.

Mean it's it's just very prohibitive.

We're just going to keep a close eye on it. If it's something you care about, it's something really to look into sending some public comment or getting up and speaking out against this bill, Senate Bill 194 was a bill to eliminate the Board of public Assist.

We are glad that has been tabled in the committee at this point, so that is good.

Kristen, can you talk a little bit about why that board of public assistance matters?

Yeah, we felt that that mattered because there needs to be a third party place that somebody who is having an appeals process with public assistance, with its snap or Medicaid, things like that.

The way that the bill wanted things to go is.

To have that board eliminated and then have those decisions just remain within dphhs. Now the board is important because on that board there is a public representative.

If somebody who is a neutral, unbiased party being able to review those cases.

Which we think is important 'cause once you keep things within an agency, there's concern about transparency and things like that.

We were advocating to have that board remain in place.

Yeah. So at this point it's.

So we're hopeful that that will continue that way.

Senate Bill 72 is provide presumptive eligibility for Medicaid coverage of home and community based services.

This has been just a really exciting bill. Like we've said, we work with people all the time that would benefit from this.

It passed the Senate Finance and Claims Committee 16 to 6.

00:04:36 Cassie

Then it headed to third reading on the Senate floor, and it passed 44 to 5.

And now it is being transmitted to the House. So that is very exciting.

Is still alive and well.

00:04:46 Cassie

We have lots of good.

00:04:47 Cassie

Like I've said, we have a whole group called the Aging Ally.

So, so many good people are up at the Capitol doing good work for people and just take comfort in that.

Lots of people are sharing voice for these bills, and if you want to add to them, we have lots of opportunities.

Another bill that was also carried by Senator Yaakovic was Senate Bill 82, establish adjustment to blindness program that passed the House Human Services COMMITT.

So that was really cool, because that means they all saw. 00:05:18 Cassie The benefit of that? 00:05:19 Cassie We love. 00:05:20 Cassie That's a good bill that will keep moving forward. 00:05:22 Cassie Don't have any other updates on that one. 00:05:23 Kendra That's so exciting that that's going to be one of the first ones we get to. 00:05:26 Kendra Now it just has to be heard on the House floor and then on to the governor's desk. And at this point, I don't see how it would get hung up. 00:05:33 Cassie So this one's this one has been moving very quickly and so that's why. 00:05:36 Kendra Yeah. 00:05:38 Cassie You never know with the process this week. Yesterday Kristen and I were able to go to the Capitol to speak on Senate Bill 300, which is providing protections for service. 00:05:48 Cassie Dogs and handlers. 00:05:50 Kristen

I am a service dog handler myself.

I've had service dogs since I 2012, so it's been.

A long experience for me. Having a service dog out in my daily life and this bill in particular is really important because it provides for protection.

Were to be attacked by a pet dog or some harm comes to that or its handler. There can be recourse now under this bill. And So what this bill allows for, first and foremost, education.

It'll be a really good educational tool because if we're able to say that it's unlawful.

To interfere with a working service dog that is, opens the door for the why? Why is it unlawful and that that elevates the professional training, the professional work and the importance of these service animals.

I'm excited to see this being as used as a number one as an educational tool now.

The opportunity for restitution, so if somebody.

Pull your dog away from my dog because my dog is a service dog. They have been officially put on to on notice and if they continue to allow their dog to interfere with your service service dog, then at that point if harm came to your dog, we could.

That that dog bit your service dog.

Now that person under this law could be held liable for those medical bills if the dog needs new training, things like that.

This is why it's really important is that it also.

Provides for some restitution for poor behavior around service animals.

Was a really great turn out.

For public comment, we had a lot of Guide Dogs in the room.

We had other service dogs in the room.

People shared powerful personal stories about how interact some interactions have created.

You know, service dogs having to be retired early or the fear of having one of their service dogs being attacked because one's coming down the hallway, barking and and things like that so.

I'm proud of everybody who showed up to share their personal.

That's really difficult to share things that are so close and at times traumatic as well, so.

Great job to everybody who was there yesterday and I'm hopeful that this bill will continue moving forward.

Lastly, we are only one of two states left in the nation who do not have this law in place, so there's 48 other states who already have a similar law in place.

In ensuring that people with service animals have.

It was really powerful yesterday and I'm not a crier and I found myself tearing up on multiple occasions really, really incredible.

House Bill 341 revises the laws related to brain injuries that allows funding.

Have talked about this on previous.

We believe the money will go to the brain injury Alliance and provides really.

Services to folks that passed House Appropriations 23 to 0.

00:09:20 Cassie

So that will be moving on to the third reading on.

Now, House Bill 245 revised the Montana Health Act, workforce development provisions and termination date, Medicaid expansion that passed second reading on the Senate floor 29 to 21 after.

Much discussion, and I think Kristen and Michelle both listened in on that session.

It is now today, Tuesday, February 25th, at Senate Finance and.

And so it needs to pass that committee. Then it will go back to third reading on the Senate floor.

We will let you know what happens and.

Fingers crossed Medicaid expansion continues to move forward.

Lots of new bills coming up because Friday is the last day bills can be introduced because they need to make it to transmit.

House Bill 574 is authorizing implementation of a the certified community Behavioral Health Clinic model.

This model aims to enhance access to comprehensive behavioral health services by establishing clinics that provide a range of mental health and substance use disorder treatments.

So this bill is, you know, new to us.

00:11:25 Cassie

Are watching it.

00:11:26 Cassie

To see it seems on the surface to be a good bill that will support, I think, some of the funds that the governor had put in his budget for mental health to create just some more.

Opportunity we are lacking, as we know when it comes to behavioral health in Montana. And so to create more robust systems would be important.

Another bill kind of in alignment with that is House Bill 576, revised funding for Medicaid and health support services to children and to adults who are aged, blind and disabled.

These are both being heard Wednesday.

26 at 30 clock in Room 152 in front of the House Human Services Committee.

House Bill 576 revises funding for Medicaid and health support services in Montana to help this population.

It looks to be using some of the tobacco settlement money to accomplish that.

So those two bills will increase funding for disability services and hopefully make them more robust.

Then we have house Bill 601, which I think everyone will be really excited about.

Create an online portal for community assistors related to Medicaid.

This is being heard Wednesday, February 26, at 3:00 in Room 152 in the House Human Services. So that committee is going to be very busy.

House Bill 601 aims to improve Medicaid accessibility, particularly for people with disabilities, by creating an online portal for community ASSISTORS. While the bill's full details are still under review, key elements that could make Medicaid easier for people to use include.

Simplified navigation, enhanced communication, better support and potential for future accessibility.

So this is being brought forward by SJ Howell out of Missoula, who has been just an incredible proponent for all things medical.

Paid and and really working toward making the system better.

I think this is one of those pieces of we talked about 2:30, which was the one Mary Cafero held. This is an example of one of the things that they wanted to increase the system and the Serv.

'S hoping to do that and it would make a big.

It we've talked about it before, like the waiting online for hours and hours and hours to get a phone call.

This does sound pretty helpful.

I just was doing.

This morning.

00:13:42 Cassie

Yeah. Michelle came in saying.

I need better system and so this is an answer to that.

If this impacts you, definitely create public comment.

In person zoom.

00:13:54 Cassie

Get your voice in there.

Support this bill. This bill matters to so many people.

House Bill 607 provides for hearing aid coverage.

00:14:02 Cassie

This is kind of cool, so it's being heard Friday, February 28th, 8:00 AM in room 172.

00:14:07 Cassie

In front of business and Labor, House business and labor.

00:14:10 Cassie

This bill aims to ensure that health insurance plans provide coverage for hearing loss treatment and devices such as hearing aids for all individuals. Before this, it has been guaranteed to children, but not to adults, so this is a very cool bill.

00:14:22 Cassie

Hearing aids are incredibly expensive. I do not think people realize just how expensive a hearing aid is.

00:14:29 Michelle

Thousands, yeah.

00:14:30 Cassie

Michelle, you do not for you personally, but we've worked on on that for someone and it's it's a lot. We also know that your chance of getting dementia goes way up.

00:14:39 Cassie

When you cannot hear.

00:14:41 Cassie

And so getting these services in place when we recognize that it's an issue is really important.

00:14:47 Cassie

Lend your voice to that Bill as well.

00:14:49 Cassie

So the next three bills are dealing with diversity, equity and inclusion.

00:14:54 Cassie

They are house Bill.

00:14:56 Cassie

618 which is provide for a Montana individual Freedoms Act. This bill restricts funding for diversity, equity, and inclusion, as well as any political or social activity.

House Bill 635 is revised human right laws to prohibit diversity, equity and inclusion programs.

00:15:13 Cassie

This bill defines adei program as any training or activity that addresses power dynamics related to race, gender identity, sexual orientation.

00:15:21 Cassie

Including discussions on systemic oppression and unconscious bias and social justice.

00:15:25 Cassie

House Bill 635 would have significant implications for people with disabilities, particularly in terms of workplace accommodations.

00:15:31 Cassie

Services and broader societal.

00:15:34 Cassie

So some of the negative impacts could be loss of.

00:15:37 Cassie

Disability focused training and awareness heritability. We've done lots of work to bring awareness to the ADA, to accessibility to inclusion.

Reduce public support for accessibility.

00:15:49 Cassie

So if state and local agencies can no longer allocate funds to these efforts, disability advocacy programs that focus on equal access, workplace inclusion and community participation could be deprioritized.

There could be barriers to employment protections.

00:16:04 Cassie

And then weakening of intersectional advocacy.

00:16:07 Cassie

So lots of different things with that. And then we have one more House Bill 638, which is revised human rights laws.

So this bill prohibits state and local government agencies in Montana from requiring or requesting diversity statements or giving preferential treatment based on the submission.

Of such statements.

So these all we've kind of had a lot of different discussions here at ability when we do our work here.

Inclusion is the cornerstone of the work we do, and so to put into our own state laws bills that prohibit.

Doing the work we do feels very dangerous, absolutely.

And so we obviously are in opposition to all three of those bills.

I just want to say, too that obviously there's a lot of this is coming from what's happening on the federal level and we haven't necessarily touched on a lot of that on this podcast so far.

Kind of focusing on the state.

But maybe in the next couple weeks we'll be putting together some other national updates because this is all tied to that.
