The number of discussion paragraphs should be longer than the introduction. The consistency of the article from the title to the discussion must be considered. Research weaknesses and suggestions for further research development are outlined in this section.

The discussion is written with 1.5 spacing and bold. The presentation in the discussion is written systematically using a sub-topic format of numbers and letters. If there are images/tables, ensure they contain data/information related to the research objectives. Tables and images are included in the body of the manuscript. Table and image titles are numbered and written in Cambria (Headings) font 12, single-spaced. For images, it is recommended to use a pixel size of 300 for optimal image sharpness and quality (preferably in JPG format).

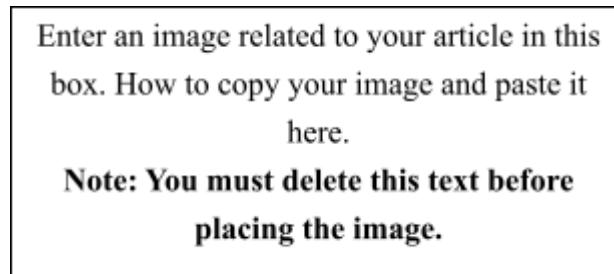


Figure 1. This is an example of a caption for an image.
