Clothing & Textile exhibitors are encouraged to participate in Fashion Revue judging and fashion show! Exhibitors can use the same garment to participate in both fashion revue and the corresponding clothing & textiles exhibit in the same year at both the county and state fair. To participate, register in FairEntry under both.

Judging and Fashion Show

Purchased Clothing and Fashion Revue will be judged on Tuesday, July 22 at the Nicollet Community Room located in Nicollet from 9 a.m. to noon. The public fashion show for Fashion Revue will be on Tuesday, July 22 at 7 p.m. at Nicollet School Auditorium in Nicollet

Bring this completed form with you to judging.

Purchased Clothing Requirements

The purchased garment or outfit must be accompanied by an 8-1/2" x 11" binder with the following information:

- Colored photo of member wearing the garment. Label photo with name, county, and color of complexion, hair, and eyes.
- Cost of garment and explanation of why garment was purchased
- Fabric content and care of garment
- Examples of ways it will be used in existing wardrobe
- Sale receipt and tags, if available

Fashion Revue Requirements

Fashion Revue is judged on the overall completed look which includes the outfit, accessories, and overall appearance

- Participants may model any clothing they have constructed, purchased, or upcycled as a part of their 4-H clothing project.
- Garments are required to be modeled during conference judging **and** the fashion show.
- Exhibitors must provide a short narrative and a photo for the fashion show. Bring this photo with you to judging.

2. How does this outfit fit into your wardrobe or fill those needs?
3. How will you be able to interchange this outfit with other items in your wardrobe?
4. List items that were important to you for your particular outfit such as movement, warmth, color, first impression, comfort, use of money, extending your wardrobe, or any other factors. Then tell us what you looked for to meet those special needs.
5. What influenced your decision most in accessorizing this outfit?



6. What limitations did you have in buying your outfit or accessories?

7. Where will you wear your outfit?

8. How do you plan to care for your outfit?

9. Itemize the cost of your outfit. List individual garments and accessories including shoes, jewelry, scarves, etc.

Your narrative for Fashion Revue- Purchased Clothing

Tips on writing your narrative:

- Start with your name and club.
- Include a description of the item you made or purchased as your exhibit, information on the type of fibers in the fabric, and other items of interest--such as item care, cost, occasion to be worn, any new experiences or learning about it, and any other factors that were important to you about this item.
- The script should be a minimum of 30 words. Please write complete sentences in 3rd person (as if someone else is reading them about you). Read them aloud to yourself, to check if they sound okay. Be as creative as possible.
- You will have a chance to revise your narrative on judging day.

Include a photo of you wearing the outfit to submit with your narrative.
