BEFORE COMMISSIONING

- TOS was mostly made to warn you about possible odds, while working with me. You may not read it, but if an issue pops out, then "Ignorance of the law is not an excuse"-thing.
- Mention the code in your order: "Ya lomai steklo". Not mandatory, just me being curious how many people are reading this.
- Make sure you really want an artwork from me and don't have any financial problems in the near future, as said in 1.3. I'm unable to provide a refund.
- Dearly ask you to not message me through any emails or FurAffinity, I don't check them often. Prefer galleries above or, if you know my Discord, feel free to contact me there too.
- I accept payment once I show you the concept(s) and you approve them, so you have more time thinking, if in line.

1. PAYMENT

1.1. The payment is possible only through Boosty\Sberbank, as PayPal is unavailable for an unknown period. Here are handy guides for paying through Boosty: 《 [Payment via boosty!](#) 》 by Ryukiro and 《 [Boosty tutorial](#) 》 by banzai.puppy.

Sometimes this platform is a hassle and may decline PayPal, so the only advice is to use the card. (I know, I know, but there's nothing I could do >_>)

1.2. Prepayment. Splitting 50% before and 50% after is for special cases. Splitting payment between two people for same order allowed as well;

1.3. I won't provide a refund in any case, as I'm simply unable to, because Boosty is a donation platform, anything you've paid is considered as gratuitous donation.

1.4. I can ask for an additional fee, if I feel that the task is overly complex.

3. COMMUNICATION

3.1. Answers without requests for changes are considered to be satisfied reaction.

3.1.1. That is, if you don't like something, it is voiced immediately, and not later. Some moments are vague stages, and I will give explanation toward them, but anyway just for the sake of letting me know mention it, so I'm aware.

3.2. Corrections are unlimited. However, let's keep it free from irrational requests.

3.2.1. Exception is for references. You can steam me with those, however, I reserve the right to ask for an additional fee for complexity.

3.3. DO NOT impose a deadline! In any case, I will be torn to pieces, but I will try to communicate about the process or changes. USUALLY, it takes 1 month for me to draw a commission, may be more, and I can warn about extension. If I haven't responded within a month (screw it, 2 weeks) - feel free to be worried, but I won't be so impudent, so it will really be something extremely serious.

3.4. Prefer to write English properly. I don't mind any style of writing, be it professional or bro-like. However, I'm still unaware of most idioms, shortened words and abbreviations. Though, I won't mind an explanation of what and how it can mean or be used. Also structure the core of your request well.

4. ITEM OF DEAL (Character, background, item, anything I'm going to draw)

4.1. By commissioning me, you're allowing me to proceed minor changes in the item's appearance to fit the composition and quality.

By minor changes I consider: Changing Saturation and Value, slightly modify markings, giving build more realistic proportions and, in some cases, modifying minor traits a little, also NOT

drawing and detailing all of 33 earrings. The item still remains recognizable and changes *will be barely noticeable*.

The exception to this rule is reference sheets, where I just do as written. I may offer you an alternative, but not tying it.

4.2. If there is an important feature that must not be edited, then let me know! I won't be editing said feature.

4.3. In no way, you can fix my work either on your own or by ordering these edits from other artists. Only I can bring artistic changes to the work.

4.3.1. Excluding changes like rescaling, cutting fragments, adding filters, words, numbers and similar. I'm also fine with AI changes.

5. CUSTOM (aka “Surprise me random character” commission type)

5.1. You give me notes on what you would like to get and I'm doing it corresponding with artistic freedom. Do not treat that as references! If you are out for a more specific and stable look in your mind, then prefer to order the reference instead.

5.2. Payment must be done in one of two ways below:

First way: you fully prepay and receive all rights toward character, even if it will end up unused or changed.

Second way: after custom is finished, you need to decide whether you want to keep the character (you pay) or not (you don't pay).

If you liked it and want to keep the design, you must send the payment. If not, then you don't pay and I have all rights on the design remaining (to resell, keep or use the rejected design however I wish).

5.3. Rules for design are present on custom commission.

6. RULES FOR DESIGNS

Applies to any design I've ever made and transferred to other people.

6.1. There are no rules, have fun ;3;

6.2. Just for clarification: My design rules spread only toward design that I've done. Anything edited is something in grey zone for me, a collab or similar, so will carry labels only for elements that were made by me, and edited stuff goes to whomever brought them.

6.3. Since I have no serious rules, then I have no pretensions of any kind, and no desire to participate in any argue. Once sold, I WON'T confiscate any adopt, design, etc for whichever reason. As well, I don't have any responsibilities for the actions of the new owner.
