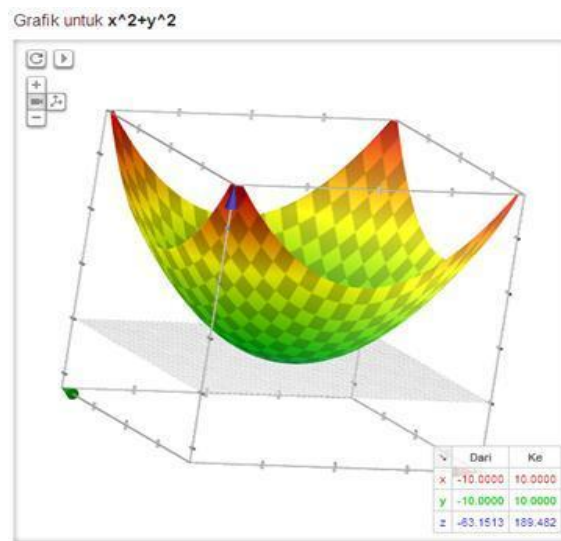


Figure 1. Graph Quadratic Equation
