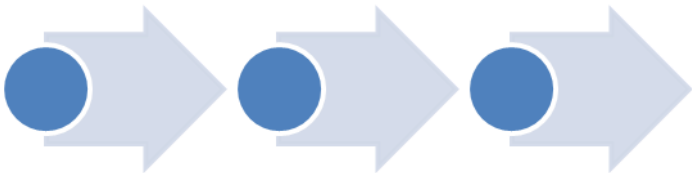


Figure 1 : Lecturer Quality Coaching
