

Privacy Policy

Section 1.Scope of Data Collection

We collect data generated when you use this app in two ways: data you provide directly to us and data generated by your activity on the app.

Data you provide directly, such as your email address. This data enables us to respond to your emails.

Data generated by your activity, such as log information, Mac address, IDFA, IDFV, GAID, device model, device brand, device language, device network type, screen resolution, etc. This data enables us to provide you with the App and our services.

Section 2.Children

We do not knowingly make the App available to children under 13 years of age. If you, as a parent or guardian of a child or children, discover that your child is using the App without your consent, you should contact us immediately and we will take reasonable steps to ensure that the child can no longer continue to use the App.

Section 3.Purpose of Data Collection

Generally speaking, we may process your data for the following purposes:

Analyzing and improving the App;

Maintenance, administration, and network and security purposes;

Handling any requests, complaints, and disputes;

Identifying, exercising, and defending our rights; and

Complying with legal obligations (including fraud prevention) and requests from authorized government agencies.

Section 4.Data Sharing

We may share your data to law enforcement, regulators, courts, or other public authorities in response to lawful requests or to protect our rights and safety.

Section 5.Data Security
