

Parliament of the Empire of Austenasia

Be it enacted by His Imperial Majesty Emperor Jonathan I, on this twelfth day of June in the year of the consulship of Domina Erena Ludovica Ducissa Bernardstoniae and Dominus Iohannes Gordonus Vicecomes Thetfordiae, by the advice and with the consent of the House of Representatives of every Town:

CXVI Jon. I 2019 (Amerdansk, Augusta and New Richmond)

1. The purpose of this Act is to establish Augusta as an AustenAsian Town, to expand the New Richmond borough of Saint Josephsburg by re-annexing former AustenAsian land, to cede the New Richmond borough of Hathawia to the United States, and to transition the Town of Amerdansk into a Crown Dependency.
2. The New Richmond borough of North New Saint Josephsburg is hereby separated from that City and elevated to the status of a Town, to be known as Augusta.
3. The Town of Augusta is in the Province of Greater Richmond, which is in the Duchy of New Virginia, which is in the Region of Northern Austenasia. Riley Kennedy is hereby appointed Baron of Augusta.
4. Lord Riley Kennedy, Baron of Augusta is hereby granted subjectship and appointed Acting Representative of Augusta, to serve in said latter position until the first local election takes place for said Town.
5. The formerly AustenAsian land at ## Ashwood Court, McCarr, Kentucky and the formerly AustenAsian strip of land which conjoins the former to the present-day New Richmond borough of Saint Josephsburg are from henceforth re-annexed from the United States of America by and to the Empire of Austenasia. The newly re-annexed land shall be a part of the New Richmond borough of Saint Josephsburg.
6. The residents and subjects of the New Richmond borough of Hathawia are hereby divested of their status as such and of all AustenAsian nationality, and any and all AustenAsian titles, offices and positions held by the former subjects and residents of Hathawia are hereby honourably withdrawn and revoked.
7. The territory which comprised the New Richmond borough of Hathawia is hereby ceded to the United States of America, although the Empire of Austenasia reserves the right to reassume sovereignty over said land should such be in accordance with the wishes of its population, and/or if the American government proves incapable of governing it.
8. The Town of Amerdansk shall from henceforth no longer be a Town, but a Crown Dependency, continuing to hold the name Amerdansk. All subjects of Amerdansk shall from henceforth be residents only, and the Duchy of Lowland and the Province of Ousten are hereby dissolved, with the Nobility of said administrative divisions hereby abolished and the Landed Noble titles connected to said administrative divisions ceasing to exist.

Lord Anthony Clark, Baron of Amerdansk is hereby honourably revoked of all Austenasian titles, honours and offices except for that of Governing Commissioner of Amerdansk, to which he is hereby appointed, to govern Amerdansk in the name of and on behalf of the Monarch.
