EXECUTIVE ORDERS**

EXECUTIVE ORDER 01

Provisions regarding the Coronavirus.

WHEREAS, the Coronavirus has been declared a Public Health Emergency of International Concern, and furthermore a Pandemic, by the World Health Organisation; and

WHEREAS, the Coronavirus has been seen to be causing immediate public health concerns and outbreaks within Rockford, and so it is clear that the Federal Government of Rockford gives it such attention.

NOW, THEREFORE, I, PRESIDENT JEFF W. FORD, pursuant to 7 SFC ch. 2 §10, on behalf of the Secretary of Health, declare a Public Health Emergency and introduce the following provisions:

(1) Definitions.—

(a) “The Coronavirus” means the Severe Acute Respiratory Syndrome Coronavirus 2 (SARS-CoV-2);

(b) “COVID-19” means Coronavirus Disease 2019, the disease caused by the Coronavirus; and

(c) “Small Businesses” means businesses that do not have links or supply outside of its local economy and populace.

(2) The Government shall order that citizens should not leave their home unless it is for—

(a) Medical purposes (Hospital, Mental Health, Pharmacy);

(b) Work (where work is a necessary service or function);

(c) One occasion of exercise each day; or

(d) Shopping for basic needs and goods.

(3) National Health Institutes, particularly those studying virology and microorganisms, should prioritise investigations on the Coronavirus, including those of vaccines and assisting such cures and treatment facilities.

(4) Pursuant to 4 SFC ch. 5 §21 (Defence Production), I compel—

(a) Medical and Chemical companies to start producing medical-grade oxygen;

(b) Fabric companies and factories start production on medical masks; and

(c) Technological and machinery companies start production on medical-grade ventilation systems and such systems alike for the purpose of respiratory care.

(5) The National Trade Bureau (NTB) shall facilitate the trading of supplies and resources and the Agency for Disease Control and Response (AfDCR) shall advise companies on production schemes, plans and advice for the purposes of Section (4).

(6) The Department of Health shall open up the Federal Emergency Stockpile of resources for this Public Health Emergency.

(7) The Department of the Treasury shall facilitate the payment of up to 75% of citizen salary for corporations and 95% of small businesses.

(a) The National Trade Bureau (NTB) shall facilitate the application process with State and Local Governments.

(8) It shall be an offence to—

- (a) Use this disease and it's virus, as a threat towards any person;
- (b) It shall be an offence to, while infected or not, to intentionally cause distress by intentionally teasing, making gestures or intentionally coughing in order to distress the public, or cause panic; and
- (c) It shall be an office to promote any theories not with evidence, not based on science, to intentionally cause confusion, distress and panic in a National Emergency.

(i) This includes social media, internet and broadcasting infrastructure.

(9) Offences made in Section (8) shall have the imprisonment length of 10 years.

EXECUTIVE ORDER 02

Occupational Health.

WHEREAS, it is clear that Occupational Health for workers and business people is a clear priority for personal health, business morale and law issues.

THEREFORE, I, PRESIDENT JEFF W. FORD, introduce the following provisions:

(1) Definitions.—

(a) “Organisation(s)” means Companies, the Construction Trade, Corporations and businesses thereof; and

(b) “Occupational Health” means ensuring the physical and mental health of such workers of all positions and roles.

(2) Organisations shall ensure that workers have at least 30 minutes break each day.

(3) Should an event happen, that would be stressful, traumatic, surprising or otherwise affecting workers, the Organization shall provide a Counselling Service.

(4) Organisations shall ensure the proper training for firearms, electronics, culinary and chemical practicalities.

(5) Office-based organisations, or such professions of the same manner in a business, shall ensure proper ergonomics and support to avoid posture issues and injury (e.g. Back Pain, Repetitive Strain Injury (RSI), etc).

(6) This Executive Order shall be enforced by the Department of Commerce and Trade.

EXECUTIVE ORDER 03

Proclamation of a State of National Emergency.

WHEREAS, it is clear that the City is in civil unrest and that it is clear, for Public Safety, that this is a clear danger to all States, particularly the Capital City.

THEREFORE, I, PRESIDENT JEFF W. FORD, pursuant to 3 SFC ch. 2 Section 1, I declare a State of National Emergency for the Federal Republic of Rockford, and authorise the appropriate powers in 3 SFC ch. 3 to the Federal Government.

EXECUTIVE ORDER 04

Lee Bio-Research Facility as National Institute of Health.

WHEREAS, in my duty as President to uphold Science and all matters regarding investigations to it, for it, for the purpose of medical procedure and to promote the clear representation that this Government shall be a Government guided by science, where duly required.

THEREFORE, I, PRESIDENT JEFF W. FORD, create the Lee Bio-Research Facility as an addition to the National Institutes of Health, and shall therefore report to, follow policy and be funded by the Department of Health.

EXECUTIVE ORDER 05

National Heritage Sites.

WHEREAS, in order for me as President to ensure that the natural beauty and the natural history of the Federal Republic of Rockford is protected, from threats against natural sites of beauty, that they shall not be damaged and the the history is protected, and to also avoid any more perceived threat against nature or heritage sites.

THEREFORE, I, PRESIDENT JEFF W. FORD, introduce the following provisions:

(1) Definitions.—

(a) “National Heritage Site” means any National Cemetery, National Monument, Designated Forest Land, Forest Reserve, Government Site or such place designated by law or by Executive Order; and

(b) “The Forest Service” means the Forest Service organisation made by District Ranger Martin Murdock.

(2) The Following places shall be designated as a National Heritage Site—

(a) The Waterways within the boundaries of the Federal Republic of Rockford;

(b) The Hudson River within the boundaries of the Federal Republic of Rockford;

(c) Union Park; and

(d) The Federal Building.

(3) The Forest Service shall have law enforcement jurisdiction over such places designated in Section (2) if such Forest Service staff have the appropriate ‘Emergency Services’ pass.

(4) This Executive Order shall not amend or otherwise tamper with any other operations that the Forest Service already does, which may not be present within this Executive Order. It shall be used to designate jurisdiction, and for official purposes.

(5) Such National Heritage Sites shall be funded by the Federal Government, and therefore are Government Property.

(6) Such National Heritage Sites shall be conserved land or of historical value, and shall not be modified, damaged or changed in for other reasons, unless there may be a National Emergency or other major reason.

(a) It shall be an offence for carrying out such damaging activities against the Conservation area, and shall carry an imprisonment sentence of 5 years.

(7) This Executive Order may be amended to allow for more Conservation and National Heritage Sites.

EXECUTIVE ORDER 06

Designation of Secret Information Facilities.

WHEREAS, in my duty to protect classified information from enemies that pose a critical threat, and to uphold the Government's Counter-Intelligence strategy and to overall support the National Security and Intelligence team in all aspects of the Federal Government, it is clear that I must act in creating these facilities.

THEREFORE, I, PRESIDENT JEFF W. FORD, pursuant to 4 SFC ch. 2 §8a, introduce the following provisions:

(1) Definitions.—

(a) "Secret Information Facility" has the same meaning as designated in 4 SFC ch. 2 §8.

(b) "Intelligence Community" has the same meaning as designated in 4 SFC ch. 1 §1.

(2) Hereby, the Secret Information Facilities (SIFs) are designated as—

(a) The Rockford Federal Building Situation Room;

(b) The Server and Network Rooms of Intelligence Communities;

(c) Intelligence Community paper and file archives; and

(d) Hardened Telecommunications, Teleconference and such systems alike used by the President, the Armed Forces and the National Security Council and other government institutions.

(3) This Executive Order may be amended whenever to allow more for Secret Information Facilities (SIFs).

EXECUTIVE ORDER 07

Regulation of the Waterways.

WHEREAS, the institutions of the Federal Government and the Citizens need clarification and rules in assurance that the waterways may be used freely but with regulation;

WHEREAS, in order to ensure wildlife protection and conservation, it is clear that it must be regulated; and

WHEREAS, in order to protect the health and welfare of the citizenry who use and live near the water systems, and health in general, it must be regulated to ensure that contaminants and such substances alike do not threaten the aforementioned.

THEREFORE, I, PRESIDENT JEFF W. FORD, create the following provisions:

- (1) No person shall reside or live in drainage systems, and are such classed as Government Property and have the same penalty as such sentence in 2 SFC ch. 2 §19.
- (2) No person shall dump any chemicals or contaminants into the waterways, or storm drains intentionally.
- (3) No person shall dump any medical information, any biomedical or medical contaminants or paraphernalia into the waterways or storm drains.
- (4) Each owner of a water vessel or vehicle shall ensure that their vessel is appropriately evaluated to ensure it shall function property to avoid rescue and emergencies, and reduce pollution and contamination from engine and propulsion devices.
 - (a) The Secretary of the Armed Forces with the Chief of Staff of the Navy shall regulate this for the Navy Branch of the Federal Republic of Rockford;
 - (b) The Secretary of Homeland Security, in conjunctions with the Secretary of the Armed Forces where appropriate, shall enforce this Section for units of the Coast Guard; and
 - (c) Each State Government shall ensure this Section is enforced for that of waterways in their jurisdiction, so that the local Police Department(s).
- (5) State Governments shall enforce such provisions of this Executive Order, as well as ensuring their own measures combating waterway pollution, along with the provisions made in Section (4)(c).
- (6) The Forest Service, in accordance with EXECUTIVE ORDER 05, shall have jurisdiction over the waterways as shall the other Federal Agencies and local law enforcement.
- (7) No person shall steal or interfere with aquatic animals and wildlife unless granted by the appropriate authority e.g. by Law Enforcement or a National Institute of Health for scientific purposes, etc.
 - (a) Such shall be treated humanely.
- (8) Offences shall be made—
 - (a) For 5 years imprisonment for that described in Section (2);
 - (b) For 10 years imprisonment for that described in Section (3); and

(c) For 5 years imprisonment for that described in Section (7), or for 10 years imprisonment if it has been found that such wildlife was not treated with respect nor humane proceedings pursuant to subsection (a) of Section (7).

EXECUTIVE ORDER 08

Proclamation of a State of National Emergency.

WHEREAS, there has been sporadic violence and conflict all around the Republic, and that it is clear to me that we must act immediately.

THEREFORE, I, PRESIDENT JEFF W. FORD, pursuant to 3 SFC ch. 1 Section 1, declare a State of National Emergency and authorise the following provisions :

- (1) The Government shall have the appropriate powers conferred by 3 SFC Chapter 2.
- (2) Citizens are to return home immediately and, if homeless, shall seek refuge within ONLY the lobby of the Hospital.
- (3) The Trading of all weaponry shall now cease effective immediately, and shall have an imprisonment sentence of 10 years.

EXECUTIVE ORDER 09

Procedure for conducting 'Punishment by Death' sentence.

WHEREAS, in order to ensure that the Death Penalty is carried out humanely and as clean as possible within the nation; and

WHEREAS, an order must be issued to the appropriate Local and Federal Law Enforcement Agencies and Correction Units in order to properly clarify and ensure that the appropriate institutions know how to carry out the Death Sentence officially.

THEREFORE, I, PRESIDENT JEFF W. FORD, introduce the following provisions:

- (1) Capital Punishment, which is that of maximum sentence of 15 years and the Death Sentence, shall only be available for crimes committed in Chapter 1 of Title 2 of the Rockford Federal Code, and for other crimes which are designated as a Capital Crime by Law.
- (2) Procedure for Imposition of the Death Penalty.—
 - (a) Nitrazepam or a Taser shall be used to induce Unconsciousness or a Comatose State, which shall then be followed by a Shot to the Skull by a Firearm, by one singular person until death is caused.
- (3) Method regarding the induction of Unconsciousness or a Comatose State.—
 - (a) If Nitrazepam is used, 15mg is a sufficient dosage for overdose causing a Comatose State or Unconsciousness.
 - (b) Nitrazepam may be administered Intravenously (IV) or Orally.
 - (c) The person sentenced to death may choose to take the Nitrazepam medication orally or intravenously if that is the chosen method, however if they fail to choose or refuse, the law enforcement officer in charge of carrying out the death sentence shall choose.
 - (d) If the Taser method is used, only one person shall conduct it and the Taser method shall be the same as any other way the Taser is used in other Law Enforcement circumstances.
- (4) Only one officer shall conduct the execution, and there may be onlookers regarding victims and the person(s) family/friends.
 - (a) An exception is made if this person is dangerous, or a national security threat where visitation may compromise security or the imposition of the sentence.

EXECUTIVE ORDER 10

Air Security.

WHEREAS, in my duty as President to enforce the air space and ensure the freedom of travel we so rightly hold, and to ensure the domestic protection of the people and country, it is paramount that I regulate and continue to create and uphold provisions for Air Travel security.

THEREFORE, I, PRESIDENT JEFF W. FORD, introduce the following provisions:

- (1) The Agency for Transport and Border Security (AFTBS) shall provide all Airports with—
 - (a) X-Ray Screening Technology;
 - (b) Handheld Metal Detectors;
 - (c) Metal Detectors; and
 - (d) Other appropriate technology for robust security of all Airports as that may be required as conditions, events, directives and situations present.
- (2) The AFTBS shall be the principal agency guiding policy for Air Security as required by their statutory function.
- (3) The Quick Reaction Units of the Air Force of the Armed Forces of the Federal Republic of Rockford shall appropriately respond to, deal with, investigate and apprehend any dangerous, hijacked, distressed, suspicious or unresponsive aircraft.
- (4) The Secretary of Foreign Affairs shall only give the consent for Aircraft of Foreign Nation(s) to enter and land at a specific airport.
- (5) Pilots, before certification, must apply and pass a Background Check.
- (6) The Department of Homeland Security, in its statutory function and being the Executive Department responsible for the AFTBS, shall also incorporate appropriate Homeland Security Police regarding Air Travel and Security.

EXECUTIVE ORDER 11

Proscribed Organisations.

WHEREAS, in my duty as President to protect the people, the democratic order and the State, it is my responsibility and legal authority, as conferred by 4 SFC ch. 2 §4 to appropriately ban organisations which pose a serious threat to the health and welfare of citizens, to the stability of the Republic, its constitution and Government.

THEREFORE, I, PRESIDENT JEFF W. FORD, create the following provisions:

- (1) Offences are pursuant to 4 SFC ch. 2 §4 subsection (a), subsection (b) and subsection (c) and therefore no offences shall be made within the Executive Order as it is clearly legislated by the Rockford Federal Code.
- (2) All organisations proscribed within this EXECUTIVE ORDER (EXECUTIVE ORDER 11) shall include its aliases and other names it is referred to and known as.
 - (a) It shall be made clear of other names aliases, while not necessarily in this Executive Order, by the Federal and State Authorities, and the appropriate local, state and federal law enforcement agencies.
- (3) This Executive Order may be amended whenever to remove and add organisations.
- (4) Proscribed Organisations of an International Nature.—
 - (a) Islamic State of Iraq and the Levant 'ISIL' (Islamic State of Iraq and Syria 'ISIS', Islamic State 'IS' and Daesh);
 - (b) Hezbollah;
 - (c) Boko Haram;
 - (d) Armed Islamic Group;
 - (e) Basque Homeland and Liberty or Basque Country and Freedom (Euskadi Ta Askatasuna 'ETA')
 - (f) Irish Republican Organisations—
 - (i) Provisional Irish Republican Army (PIRA);
 - (ii) Irish National Liberation Army (INLA);
 - (iii) The Real IRA (RIRA);
 - (iv) Continuity Irish Republican Army (CIRA);
 - (v) Cumann na mBan;
 - (vi) Fianna Éireann;
 - (vii) Irish Republican Liberation Army (IRLA);
 - (viii) New Irish Republican Army (NIRA);
 - (ix) Óglaigh na hÉireann (RIRA splinter group);
 - (x) Real Irish Republican Army (RIRA);
 - (xi) Original Irish Republican Army (OIRA); and
 - (xii) Irish People's Liberation Organisation (IPLO).
 - (g) British/Northern Irish Loyalist Organisations—
 - (i) Ulster Volunteer Force (UVF);
 - (ii) Ulster Protestant Volunteers (UPV);
 - (iii) Ulster Defence Association (UDA);

- (iv) Red Hand Commando (RHC);
 - (v) Ulster Resistance (UR); and

- (5) Proscribed Organisations of a Domestic Nature.—
- (a) A37 Gang;
 - (b) Greater Marionian Reich;
 - (c) Evocity Revolutionary Front; and
 - (d) Beijing Red Guards (Red Guard Militia).

EXECUTIVE ORDER 12

Reorganisation; renaming the NSFIA.

WHEREAS, in my powers as President as the head of the Executive Branch and subsequently head of Government and Chief of State as granted by the Federal Code and the Constitution, I use this power to enact a small change of name to a federal agency.

THEREFORE, I, PRESIDENT JEFF W. FORD, create the following provisions:

- (1) For this order, the “NSFIA” means the National Security and Foreign Intelligence Agency under the Department of the Armed Forces.
- (2) The NSFIA shall be renamed to the Agency for Foreign Intelligence, with it's subsequent abbreviation 'AfFI'.
- (3) No other changes shall reflect the agency, except for the appropriate officers and positions where their name shall change once this order is published.
 - (a) This includes the Director, as the Director of the Agency for Foreign Intelligence, and so on which shall change, along with all other acts, laws and orders, when this order is published.
 - (b) Such new titles and names reflecting the name change of the agency shall go into effect once this Executive Order is registered in the Office of the Federal Register, and such names will need to be reflected on documents and government websites, etc.
