Information We Collect

We collect only the information necessary to provide services and improve user experience, including:

- Personal Identification: registration, counseling, or onboarding (website forms, portals).
- Academic / Professional Data: admissions, test prep, and training records (student or partner submissions).
- Contact Information: communication and verification (email, WhatsApp, or official forms).
- Analytics Data: site optimization and user experience (Wix Analytics, Google Analytics).

We do not collect sensitive financial or biometric data through this site.

How We Use Your Information

We use collected information to:

- Provide and personalize Student Advocacy Services;
- Verify consultancy and university partnerships;
- Communicate updates, reports, and training opportunities;
- Improve website usability and system performance;
- Support impact reporting for the KGE Foundation's reinvestment programs.

We will never sell, rent, or trade personal data to third parties.

- Verified partners and universities for legitimate admissions or support purposes;
- KGE Foundation programs for scholarship or fellowship tracking;
- Technology providers (Wix, Airtable, Google Workspace) strictly for platform functionality.

All third-party systems used by KGE comply with international data protection standards (ISO/IEC 27001 or equivalent).

We take data protection seriously. KGE implements layered security measures, including:

- Restricted database access;
- Two-factor authentication for internal users;
- Encrypted cloud storage for sensitive records;
- Regular compliance reviews.
