When I first took my position with FDLRS as an HRD (2019), I attended the SIM Annual Update with my colleague Heather Theobald, a SIM Professional Developer for Learning Strategies. I was very interested in pursuing the certification to become a SIM Professional Developer for Content Enhancement Routines. I trained in Concept Comparison with Jane Hines and Cindi Medici.
