### **SSDI** and **SSI** Benefits

Many individuals wonder how to apply for disability in California and their options. If you have a long-term disability, you can receive benefits through the United States' social security system. Benefits are available through two programs: Social Security Disability Insurance and Supplemental Security Income.

Under both programs, individuals must meet the SSA's disability criteria. However, there are additional eligibility requirements for both programs and a difference in the benefits. Your attorney can help you determine your eligibility for each program and make a plan for claim filing.

#### SSDI Benefits

Eligibility for SSDI is based on an individual's work history. Applicants must have sufficient work credits to meet SSDI requirements and have six full months of disability before they can begin receiving benefits.

Funds for these benefits come from the disability trust fund the individual paid into from contributions. Benefits are based on the participant's lifetime average earnings

#### SSI Benefits

Eligibility for SSI is based on financial resources and age. Applicants are eligible to receive benefits one full month after the claim was filed or the date found eligible.

Funds for these benefits come from tax revenue and participants are not required to have made Social Security contributions to receive benefits. Benefits are based on the standard federal benefit rate and then reduced by the participant's countable income.

# How to Apply for Disability?

It is crucial to take the right steps to secure your rights to receiving disability. Missteps and mistakes can cause your claim to be denied or benefits delayed. While the specific actions you should take will depend on your condition and the status of your claim, here are some general actions you should take to secure your right to benefits.

- Gather supporting documentation including your identifying information and medical records. Prior to applying, you will want to be certain to seek medical treatment for your condition and collect medical records and other documents that support your inability to participate in gainful activity.
- 2. Apply online <a href="https://www.ssa.gov/apply">https://www.ssa.gov/apply</a> or at your local SSA office. Your disability attorney can file your claim on your behalf.
- Be certain to fill out the disability application completely and accurately. Failing to
  do so can result in denial or delays. Working with an experienced social security
  lawyer can help reduce the chances of these kinds of mistakes.
- 4. Respond to all requests for information and attend any physician appointments requested by the SSA.
- 5. If your claim is denied, determine the reason for the denial and options to appeal.

# Eligibility Criteria for Social Security Disability

To be eligible for disability benefits, you must have a medical condition that makes you unable to participate in gainful activity. In addition, there are specific work credit requirements that individuals must meet to receive SSD. Individuals can earn up to 4 work credits every year, with the number of credits earned based on their total yearly wages or self-employment income.

The number of work credits required to receive SSD is based on the applicant's age at the time of disability. In general, individuals need 40 credits to be eligible for benefits, 20 of which need to be earned within the 10 years preceding their disability. However, younger individuals may qualify with fewer credits.

If you are uncertain whether you qualify for SSD, a social security disability attorney can help. They can verify the number of work credits you need to qualify and the credits you have earned.

### What if My Disability Claim is Denied?

If you were denied social security disability all hope is not lost. Our lawyers can determine why your claim was denied and the steps to take to reapply or appeal your denial.

You have four opportunities to appeal a claim denial:

- 1. Request for reconsideration
- 2. Hearing before an administrative law judge (ALJ)
- 3. Review with Appeals Council
- 4. Federal Court Appeals
