Attendance Policy

(version en español)

Overview - One of the most significant factors affecting school success is regular attendance*. Students must be in class on time and prepared to learn (homework completed, necessary books and supplies ready).

*Pursuant to California Education Code, it is the duty of each parent, guardian or person having control or custody of a minor, to compel and guarantee regular and prompt attendance to class.

Excused Absence Notification and Recovery

- When a student is absent, the PARENT or GUARDIAN must contact the school and verify the reason for and the dates of the absence within 30 days of the absence. (Sweetwater Union High School District Board Policy 5112). If it is not excused within the ten days, students must attend Attendance Recovery/Saturday School to clear the absence (SUHSD Board Policy 5112). Students who miss more than one day in a month are subject to placement on an attendance contract.
- Note: Excusing a student's absence does not mean the absence is erased from the student's file.
- Students may occasionally need to be absent for illness, emergencies, etc. In such cases, it is suggested to attend Saturday School for each day they missed school. Students have the responsibility to arrange make-up work with their teachers.
- Call our Attendance Office at (619) 662-8200.

• Student absences relating to participation in approved school activities (Knowledge Bowl, Band or Mariachi concerts, etc.) are considered school excused.

Unexcused Absences - An unexcused absence/truancy is when a student is deliberately absent from school and/or class without the knowledge or consent of their parents or the school. Student absences may be monitored by parents. Contact the Attendance Office at 662-8200. *The automated attendance calling system will call home after each unexcused absence.*



Tardy Policy

Overview - Punctuality is an important life skill and tardiness is extremely disruptive in the educational process. Please understand that when a student is tardy, they interrupt the instruction of other students in a class when the teacher must stop instruction to adjust attendance records and catch the tardy student up.

- A student is considered tardy if he/she is not in their seat when the tardy bell rings.
- Students that are late will get a tardy slip from the main office before attending their class. Excused tardies are issued if a student returns from a medical or dental appointment during a period or the parent contacts the office to excuse a tardy. Students are responsible to make up for all missed work for that period.

Tardy Consequences

- A student that has 12 or more unexcused tardies will be assigned Saturday school.
- Citizenship grades may be lowered if a student is excessively tardy.
- Students that are tardy during a sweep, will serve after school detention the same day.

Academic Honesty at Montgomery Middle School

Overview - Academic honesty and personal integrity are fundamental components of a student's education and character development. Montgomery Middle School expects that students will not cheat, lie, plagiarize, or commit other acts of academic dishonesty. The well being of the entire school community depends on the student accepting responsibility for personal conduct in both social and academic endeavors.

Plagiarism is not tolerated at Montgomery Middle School. Plagiarism includes (but is not limited to) the following:

- Using someone else's words or ideas without proper citation
- Copying someone else's work and calling it your own
- Copying and citing a work that is longer than a paragraph (print or online sources)

Cheating is work that doesn't reflect your own effort and understanding. This can take many forms and will not be tolerated at Montgomery Middle School. **Do not give the appearance of cheating.** Cheating includes (but is not limited to) the following:

- Looking at others' answers on tests and homework
- Taking someone else's paper and putting your name on it
- Copying someone else's work, answer for answer
- Rearranging words from someone else's work
- Allowing someone to copy from your paper
- Telling someone else the answers on an assignment or test
- Having someone else do your work for you (Friends, Family, Tutors, etc.)

There are **other forms of academic dishonesty** that will not be tolerated at Montgomery Middle School. They include:

- Making up data for an assignment
- Claiming to have handed in an assignment when the student knows they have not done so
- Sabotaging someone else's work

Teachers and administrators will support each other in cases of academic dishonesty. In any case of academic dishonesty or the appearance thereof, **teachers may give a zero on the assignment or the student may be given the chance to redo it for a lesser grade.** It is the hope of the teachers and administration at Montgomery Middle School that all students will be honest in all of their academic endeavors.



Dress Code

(version en español)

Overview - The Board of Trustees believes that appropriate dress and grooming contribute to a safe, healthy and productive learning environment. The Board expects students to give proper attention to personal cleanliness and to wear clothes that are suitable for the school activities in which they participate. Students' clothing must not present a health or safety hazard or a distraction which interferes with the education process.

Clothes that promote drugs, alcohol, tobacco, gang attire or violence are not permitted. Clothing that contains suggestive, obscene or offensive messages or graphics that demean others based on ethnicity, appearance, religion, gender, sexual orientation, or those with disabilities.

• Administrators reserve the right to interpret or alter these guidelines to promote an age-appropriate educational decorum.

If your child is deemed to be inappropriately dressed, they will be referred to the main office by staff and required to change into more appropriate attire provided by either the parent or the school. In addition, students will receive additional consequences for each instance they are not appropriately dressed as described below.



Violation - Students who violate the dress code will have the following consequences. All violations warrant a change of clothing:

- Violation 1 Warning, change of clothes
- Violation 2 Lunch Detention, change of clothes
- Violation 3 Friday 1-hour Detention, change of clothes
- Violation 4 Saturday School, change of clothes
- Violation 5 In school suspension & Parent Conference

If there are any questions as to whether a particular item is appropriate for school, please contact an administrator who makes the final decision.

Halloween Costume Guidelines

- 1. No masks (for safety/security reasons), face paint is ok.
- 2. No weapons of any kind (fake or real)
- 3. No costumes that are culturally or racially insensitive or would offend anyone regarding ethnicity, religion, gender, sexual orientation, etc...
- 4. No costumes that are excessively gory or bloody
- 5. No one may wear excessively short skirts/dresses or revealing tops (no bare midriffs, no tube tops, no halter tops, no spaghetti straps). If you are unsure if your costume is too short, make sure you wear leggings or pants underneath.
- 6. No costumes that are sexually suggestive or explicit in any way.
- 7. Shoes need to still be appropriate for school. No high heels.
- 8. No political figures.
- 9. No clowns.



P.E. Class Information

Dress Code for PE

Acceptable attire for participation in physical education is clothing and shoes that allow students a full range of motion and unhampered participation in physical activities and which is consistent with the school dress code.

For your convenience, clothes for physical education may be purchased in the ASB at cost. If preferred, plain blue shorts or pants and a gray or white t-shirt may be purchased elsewhere.

LOCKS

It is recommended that you purchase the PE lock from ASB because it has a security key feature on the back, and the school will have a record of the combination in case it is forgotten. If you choose to purchase a combination lock (no key entry locks) somewhere else and the lock needs to be cut off the student's locker for a justifiable reason (forgot combination, suspicion of illegal items in locker, etc...) you will be responsible for purchasing another lock.

LOCKERS

Lockers will be issued to students by the PE teachers. Students may not change or share lockers without teacher permission. Students are responsible for locking up their own belongings. The school cannot be held responsible for lost or stolen items.

LOCKER ROOM RULES/CONDUCT

Students are to act responsibly at all times. The following items and behaviors are prohibited in the locker room:

- No Gum, food, or drinks (water acceptable)
- No Aerosol spray cans such as hair spray or body spray (Pump-type spray and roll-on deodorants are acceptable)
- No Glass bottles or containers
- No Marking pens (sharpies or permanent markers)
- No Running, snapping clothing, throwing objects, pushing, shoving, body shots, fighting, and stealing
- No Whistling, yelling and making of loud noises
- No use of cell phones, taking pictures or video in a locker room is prohibited

P.E. MEDICAL ISSUES



Students who have medical issues MUST have the proper medical form filed with the school nurse. **These forms MUST be completed by a licensed physician.** Parents can provide a one-day exception from PE pending a doctor's appointment to complete the adequate form. **All forms must be turned into the Nurse immediately.**

iPad Rules and Procedures

(version en español)

iPads at Montgomery Middle are provided to support students' educational goals by facilitating communication, research, creativity, innovation, and resource sharing. Access to an iPad is a privilege that carries responsibility and behavioral expectations consistent with all school rules and policies. Students must use iPads in a responsible, ethical, and legal manner at all times.



Student Rules for Responsible iPad Use:

- Bring iPad to school each morning with the battery fully charged. A fully charged iPad should easily last through the school day.
- Taking unauthorized pictures/video and cyberbullying is *strictly* prohibited.
 - o California Code Education Code CA Educ Code § 51512 (2018)
 - The Legislature finds that the use by any person, including a pupil, of any electronic listening or recording device in any classroom of the elementary and secondary schools without the prior consent of the teacher and the principal of the school given to promote an educational purpose disrupts and impairs the teaching process and discipline in the elementary and secondary schools, and such use is prohibited. Any pupil violating this section shall be subject to appropriate disciplinary action.
- Report all malfunctions, damages, or loss of an iPad to the library immediately.
- An iPad should only be used by the student to whom it was issued. You are responsible
 for all activity or damages on your iPad; do not loan it to friends or family, nor leave it
 unattended.
- iPads should **not** be reset nor synced to another device. You should not remove any SUHSD master profiles.
- Do not personalize an iPad with stickers or remove tags/barcodes

Irresponsible use of iPads will result in disciplinary actions which may include:

- Notifying Parents
- Temporary Loss of iPad Privileges for the class period
- AP Referral
- Confiscation of iPad
- Suspension
- Legal Action and/or Prosecution

- 1. iPad contract **MUST** be signed by parent and student before iPad distribution.
- 2. iPad User agreement pages will **only** be mailed home for parent signature or opt out signature.

CELL PHONE POLICY

(version en español)

In accordance with California Education Code, Section 48901.5, schools regulate the possession and use of cell phones while students are on campus or attending school events. Cell phones have become a way of life, a technological convenience that has impacted all of our lives in one way or another. However, in the school environment, cell phones have become a distraction, an interruption, and a method of cyber bullying.

Research supports that learning is impaired when students have a cell phone.

- The effect of cellphones on attention and learning: The influences of time, distraction, and nomophobia

- Harvard Study: Technology and Student Distraction
- Brain Drain: The Mere Presence of One's Own Smartphone Reduces Available Cognitive Capacity

Due to the research and our pursuit of creating the absolute best learning environment, students are NOT permitted to use cell phones at school, including during the before and after school program.

The students have to put their cell phones away in their backpacks when they enter the school and can take them out when they exit the school. Cell phones cannot be in any clothing pocket either.

If a student violates this policy and a cell phone rings or is seen being used by a staff member during any point of the school day (including lunch or passing period), it will be confiscated and turned in to the administration.

Cell phones will be returned *ONLY* to a parent or guardian after the first violation. Consequences will be applied after the 2nd violation.

- Violation 1: Warning and student pick up after school



- Violation 2: Parent or guardian must pick up cell phone
- Violation 3: 1-hour Friday detention and Parent or guardian must pick up cell phone
- Violation 4: 2-hour Friday detention (served on 2 consecutive Fridays, 1 hour each) and Parent or guardian must pick up cell phone
- Violation 5: Saturday school and Parent or guardian must pick up cell phone

The school is not responsible for any lost, damaged or stolen cell phones and will not investigate matters therein.

Parents are urged to call the school to relay any urgent messages. Please refrain from texting/calling your child during school hours. We will do our best to relay any urgent information to your child as quickly as possible. Students will also have access to a school student phone if they may need to contact parents.

CALLING HOME:

- Students may use the office phone during the school day.
- If you feel sick you **MUST** go see the nurse; you may not use your cell phone to call home.

Other Student Expectations

PEP RALLY/ASSEMBLY BEHAVIOR

- Enter the pep rally/assembly area as directed and be seated quickly in the assigned area.
- No eating during assemblies.
- No throwing objects.
- No video recording.
- No booing or inappropriate outbursts. Laughter and applause are appropriate at most assemblies but only in response to the assembly program.
- No talking or other rude distractions while an assembly is in progress.
- Follow all spoken directions quickly and courteously.
- Remain seated until your section is specifically dismissed. *Do not dismiss* yourself.



BULLYING

Bullying, in any form, is **not acceptable** at Montgomery Middle School. Bullying can be pushing, shoving, hitting, and spitting, as well as name calling, picking on, making fun of, laughing at, and excluding someone. Cyberbullying can be name calling, picking on, making fun of, making threats to, spreading rumors about, and excluding someone. All types of bullying cause pain and stress to victims and are never justified or excusable as "kids being kids," "just teasing," "just playing around" or any other rationalization. Bullying can be reported to any adult on campus, teachers, counselors and administration. Disciplinary actions and consequences may arise if a student bullies or participates in any type of bullying which includes, but is not limited to: warning, reprimand, peer mediation, detention, Saturday school, suspension, etc.

SKATEBOARDS/SCOOTERS/BICYCLES

Skateboards are not allowed at school. Although, you may ride a bike or scooter to school. Due to safety and liability concerns, strict rules apply when riding a bicycle to school as well. Students must wear helmets to and from campus. Students must have a lock to secure the bicycle to the bike rack. Bicycles must remain locked all day. Bike owners cannot go to the bikes during the school day. Riding bicycles/skateboards on campus is absolutely prohibited.

Strengths-Based Discipline

Goal: The Goal of Strengths Based Discipline is to help middle school students transition from elementary school with a focus on character development, evaluating consequences for their actions, and improved behavior. The use of Strengths will help students see value in themselves and use those strengths to become the best version of themselves.

In Class Discipline Steps

Each day, a child starts over on the Classroom Discipline Steps. Classroom teachers are expected to be clear and fair in delivery of discipline so that students know what to



expect. Students are to be given 2 warnings before a referral is written unless a behavior is so egregious that it warrants an immediate Assistant Principal referral.

- 1. Warning; strengths-based discipline response
- Second warning; consequences in classroom with student reflection (i.e., move seat, warning card, private conference with student, sent to buddy teacher)
- 3. Referral Referral to Assistant Principal to assign the next level of consequence on the Progressive Discipline

Consequences for Assistant Principal Referrals

Students should have a clear understanding of what will happen when they receive an Assistant Principal referral. For each referral, Assistant Principals will:

- a) assign a consequence
- b) discuss strengths with the student
- C) contact the parent

Students with more than one referral will receive progressive discipline. Teachers will also be required to contact the parent via email, Jupiter, or phone after submitting the referral.

• Lunch Detention/campus beautification

 Lunch detention is served in a classroom for 15 minutes. Students will be able to eat their lunch after the detention is completed.

• After school detention

After school detention is a minimum of 15 minutes.

Friday Detention

Friday School is a one hour detention on Friday, immediately after school.

Saturday School

- Students will attend Saturday school from 8am-12pm. Students are required to bring work to do or a book to read.
- In-person parent conference/ suspension/academic behavior contract



• Placement on Non-Privilege list

 Students will not be able to participate in pep rallies, promotion ceremony, school dances, 8th grade picnic, color run, Mayan Revolution, field trips, etc

Other Interventions

In addition to the Progressive Discipline steps, other types of interventions will simultaneously include:

- Student Study Teams
- Behavior Contracts
- Daily Progress Reports
- Intervention by Counseling Staff
- Restorative Approaches

- Individual/Group Counseling
- Mentoring
- Referral to Community Based Organization

Consequences for More Severe Behavior

SATURDAY SCHOOL

Students are assigned Saturday School by their teacher for academic intervention/support. You can also attend Saturday School to clear an excused absence. It is held monthly on a Saturday morning from 8:00 a.m.- 12:00 p.m.

CLASS PERIOD SUSPENSION

Students may be suspended from a class period by their teacher. The teacher will fill out the form and contact the parent for a parent conference. The conference must be held **before** the student returns to the classroom.

IN-SCHOOL SUSPENSION

When you are placed in-school suspension, you are not allowed to attend your regular classes, but are assigned to one room away from other students to do your work. When placed on in-school suspension, you lose all privileges.

SUSPENSION

A suspension is a legal action in accordance with California Education Code Section 48900; a record of the suspension becomes part of the student's permanent record. The grounds for the suspension are very specific and are provided under the Education Code. When a student is suspended from school, he/she loses the privilege of attending any classes from 1-5 days. Following suspension, a student may not return to school until a parent conference has been



held. If subsequent suspensions occur, then placement in another program may be recommended.

Suspended students are placed on the Non-Privilege list and may not be able to participate in pep rallies, promotion ceremony, school dances, 8th grade picnic, color run, Mayan Revolution, field trips, etc.. 8th grade students may attend an Appeals meeting in April to regain the privilege of participation in the Promotion ceremony.

EXPULSION

Recommendation for the expulsion of a student from the district is the most severe form of discipline available in a public school. The Principal of the school makes the decision to recommend this action. There are mandatory reasons an expulsion may be recommended. They are as follows:

- 1) Sale of drugs or narcotics
- 2) Possession of a firearm
- 3) Brandishing a knife
- 4) Sexual assault/battery and/or other infractions
- 5) Serious bodily injury

When an expulsion is recommended, an administrative hearing panel at the district office reviews the incident and then makes a recommendation to the school board. Only the Board can make the decision to expel a student. While waiting for the outcome of the process, the student may not return to school and he/she is placed in an alternative program. If expelled, the student may not return to any school in the district. An expulsion generally also includes involvement by the police department and may last up to three semesters.

Things you should know:

ARE YOU READY TO LEARN?

You are expected to come to school prepared to learn. You should bring all necessary supplies; iPad, textbooks, AR book, pencils/pens and notebooks. All materials brought to school should be free of graffiti, notes, drawings or pictures. Not complying can result in administration intervention and result in a fine.

STUDENT GOVERNMENT/ASB

The Associated Student Body is **ALL** of you. Your elected officers and appointed commissioners plan the events and activities that take place during the school year. Each advisory also has elected ASB Representatives who attend monthly ASB council meetings and report to their assigned advisories. Students are encouraged to get involved by becoming ASB Advisory Representatives.



ASB STORE

The ASB store is open during school (check with the ASB store for operation hours) and after school to allow students to purchase clothes, locks, school supplies, school sweatshirts, dance tickets and yearbooks. By purchasing at the ASB store you are supporting our fundraising for student programs and activities at Montgomery Middle School!

BEFORE AND AFTER SCHOOL PROGRAM/CLUB MAYA

The before and after school activities office has a lot of fun activities for you! Stop by **Room 408** to get an application.

Sports

All students have the opportunity to try out and participate in sports. Students must **maintain a minimum academic GPA of 2.0**. If a student's GPA drops below 2.0, they may remain on the team and practice, however, they will not be permitted to participate in games.

HALL PASSES/BATHROOM USE

Teacher will provide the student with a color-coded pass that must be carried with the student to the restroom and back to class. Only **ONE** pass may be used at a time per classroom. **Passes are not allowed during the first and last 10 minutes of class**. You will be sent back to class if you do not have the color-coded bathroom pass. If you see unruly behavior in the bathroom please tell a trusted adult on campus.

Misuse of the bathroom pass (i.e. wandering around, loitering in bathroom, etc.) will result in consequences such as lunch detention or 1-hour Friday detention after school.

DANCES

- 1. Attending a school dance is a privilege earned by respectful and appropriate behavior. The administration may deem a student unable to attend if students accrue referrals, defy school rules or placed on the non-privilege list.
- 2. Students wishing to attend the dance must get their parents permission to attend by having them fill out the bottom of this permission slip and turning it in at lunch. Students will be given wristbands the day of the dance which will serve as their understanding of the rules and admission to the dance.
- The school cell phone/electronic device policy is in effect during school dances.
- 4. The school dress code is enforced during dances. All outfits will be checked at the doors by an administrator. Only those in dress code will be allowed to enter and remain at the dance.
- 5. Sexually suggestive dancing is not permitted (i.e. freaking, grinding, twerking, etc.). The allowable types of dancing will be at the sole discretion of the chaperones. The first time a staff member or parent chaperone witnesses this type of dancing, the parties involved will be escorted off the dance floor, their parents will be contacted, and by allowing their student



to attend the dance, agree that if their student violates these guidelines, they will pick up their student(s) from the dance as soon as they are contacted.

- 6. No in and out privileges.
- 7. Parents may withdraw their permission for their student to attend the dance at any time.

FOOD SERVICES

For those students who do not bring lunch, the school provides cafeteria services. For the 2024-2025 school year, all students will receive a free nutrition break and lunch. You are expected to be neat and orderly at all times during lunch. BREAKFAST is served on minimum days at 7:45am.

GUIDANCE AND COUNSELING

Each student is assigned a counselor alphabetically according to your last name. Your counselor is the person with whom you should feel free to discuss any problems that may arise. Information about your program, promotion, courses and career planning may be obtained from your counselor. Arrangements to see the counselor are made by completing a "Request to see Counselor" form which may be picked up in the Counseling Center.

In order to meet promotion requirements students need a minimum of 21 credits (Each class passed equals one semester credit) and complete all **MATH, ENGLISH/LANGUAGE ARTS, SOCIAL SCIENCE, SCIENCE AND PE** courses with a passing grade (A, B,C,D).

ID CARDS

Each student receives an ID card which needs to be brought to school **everyday**. This card will be required for identification for all Mayans. The ID also serves as the library card, and must be presented for all library transactions. There will be a \$2 charge to replace a lost ID card. See the librarian to buy a duplicate card.

LIBRARY

The library is open for student use before school at 7:45 a.m., Nutrition Break, lunch and after school until 3:30 p.m. You may use the library to check out books, read magazines, or do homework and research.

IPADS/TEXTBOOKS

You are responsible for your iPad and books checked out to you. iPads are **NOT** allowed to be used during nutrition break or lunch time. You may use your iPad for school purposes in the library and/or designated areas around campus during NB and lunch break.

DO NOT lend iPad, books or leave them anywhere. You are responsible for this device.



- iPad and Textbooks are required to be covered at all times. Use proper covers.
- Fines for damaged or dirty books are assessed. You are encouraged to clean all your books.
- Before you move or leave the school, you must return all books and pay fines.
- Report cards, certificates, and school privileges may be withheld from those students who do not clear their library records. All records are forwarded to the high school.
- The library accepts only cash payments.

MAGIC CENTER

FREE TUTORING AT MAGIC CENTER! Monday through Thursday 3:30-5:00 p.m. You can do all of your class assignments and homework with the help of teachers, college tutors, and computers!

MEDICAL ISSUES

If you must take medicine at school, a form must be completed by your doctor and filed with the nurse. Medication, including those purchased over the counter, must be left with the nurse and taken in the nurse's office. Students who have medical issues MUST have the proper medical form filed with the school nurse. These forms MUST be completed by a licensed physician. This includes PE notes for non-participation in PE class. These forms must be turned into the nurse.

NURSE

If you are injured or become ill during school, the nurse's office is located in the main office. Unless it is an emergency, you must have a **Nurse's Pass** from your teacher before reporting to the nurse's office. The nurse's office is closed after lunch for 30 minutes, which is when the nurse takes her lunch. After lunch and nutrition break, you **must** report to class first and ask your teacher for a nurse's pass. **If you do not feel well, you may NOT use your cell phone to call home.** The nurse will evaluate you and determine if it's necessary to contact your parent/guardian.

SLEEP RECOMMENDATIONS

As you can imagine, poor sleep can negatively affect a student's grades and increase the odds of emotional and behavioral disturbances in the classroom. The American Academy of Pediatrics recommends that adolescents get at least nine hours of nightly sleep. The American Academy of Sleep Medicine (AASM) offers the following tips on how to get a good night's sleep:

- Follow a consistent bedtime routine.
- Establish a relaxing setting at bedtime.
- Get a full night's sleep every night.
- Avoid foods or drinks that contain caffeine, as well as any medicine that has a stimulant, prior to bedtime.



- Do not stay up all hours of the night to "cram" for an exam, do homework, etc. If after-school activities are proving to be too time-consuming, consider cutting back on these activities.
- Keep computers and TVs out of the bedroom.
- Do not go to bed hungry, but don't eat a big meal before bedtime either.
- Avoid any rigorous exercise within six hours of your bedtime.
- Make your bedroom quiet, dark and a little bit cool.
- Get up at the same time every morning.

Discipline Glossary & Student Policies & Regulations

Listed below is a **short** overview of **UNACCEPTABLE TYPE OF BEHAVIOR** that can impede the learning environment. If students choose not to follow school rules, they risk the chance of receiving varying degrees of consequences.

ASSAULT/ BATTERY: Actions which result in the threat or injury of another.

ATTENDANCE AND TARDINESS: All students are expected to be in school everyday and arrive to all classes on time. A student is considered tardy if not in class when the tardy bell rings.

BIRTHDAY "HAZING": Any action that disrupts the campus and unnecessarily embarrasses or endangers another person (slapping, spanking, egging, milking, juicing) etc.

CHEATING: When a student copies work or allows work to be copied; including AR reading exams.

DEFACING PROPERTY/VANDALISM: Damage of school or private property. For example: Graffiti.

DEFIANCE OR DISRESPECT: When a student refuses to obey and defies the authority of a staff member. When a student is rude or talks back to staff members.

EXPLOSIVES: Explosives of any kind (including matches, cigarette lighters, caps, firecrackers, cartridges, aerosol cans, stink bombs, poppers, etc.).

FIGHTING: Mutual combat-two or more people fighting each other regardless of who is at fault or who starts the fight. This includes slap-boxing.

FORGERY: When a student signs someone else's name.

GUM: Gum is not allowed on campus. Students may not chew gum at any time on school grounds.



HARASSMENT OF ANY KIND: Any act that injures, degrades, intimidates, or disgraces a fellow student. This includes any type of bullying or cyberbullying.

PROFANITY: Unacceptable language or vulgarity indecent/vulgar-inappropriate speech, gestures, slogans or pictures.

PROHIBITED ITEMS: Permanent markers (sharpies) and aerosol paint. Valuable items such as cameras, radios, airpods, iPods, and no liquid white-out. Toys such as water pistols, balloons, skates, roller blades, electronic games, pets or animals; slam books, playing cards; anything used for gambling, controlled substances, tobacco, alcohol, drug paraphernalia, weapons, realistic looking weapons, lighters or matches, devices and explosives.

PUBLIC DISPLAYS OF AFFECTION (PDA): Students may not engage in any public displays of affection, which include, but are not limited to, kissing, hugging, and groping.

SEXUAL HARASSMENT: Harassment of a sexual nature, could be physical, verbal or visual. Including de-pantsing.

SUBSTANCE ABUSE: Possession, use, sale, or otherwise providing any controlled substance, drug, narcotics, intoxicants, alcohol, vapes or tobacco products on campus.

THEFT/ EXTORTION: Stealing school or private property or threatening theft from another person.
