

# Rent Forgiveness Playbook

The Indie Theatre Community Needs You to Contact Your Representatives.

Well, it's been over a year now—after 12 months of forced shut-downs, the urgency to **#CANCELRENT** remains.

Today we're calling members of the State Legislature who have not yet signed on to co-sponsor this legislation, and telling them why they should, as well as calling members who DO co-sponsor the bill, and thanking them /slash/ encouraging them to help get it moving through the legislature. See the <u>Assembly version</u>, <u>A.3190</u>, <u>here</u>; and the <u>Senate version</u>, <u>S.3349</u>, <u>here</u>.

It's a critical time for #CANCELRENT right now -- the state is putting together the budget, and we want to make sure this is a priority!

First, call **YOUR** member of Assembly and Senator!

And, of course, the Governor represents you, too!

# **SCRIPTS**

#### Call those who DO NOT CURRENTLY co-sponsor with this script:

"Hello, my name is [your name], I'm calling with a message for [Representative]; can I leave it with you?

I'm calling because I am a member of the independent theatre community. I make and enjoy theatre in small venues throughout the city, [and I live in your district] or [including some in your district, like (see above)].

Since March of last year, indie venues have been closed by government mandate, to help prevent the spread of Covid-19—in essence, legally prevented from earning revenue. While the Governor has said venues can re-open at 25% capacity starting next month, between infrastructure upgrades, PPE, and staffing requirements to enforce new protocols, even

fully-selling-out 25% capacity houses would not come close to a "break-even" point. Plus, as most of our indie theaters rent their spaces, they're still technically on the hook for all of their back rent. Without help, there is no way these venues can survive.

Senator Hoylman and Assembly Member Epstein have come up with a plan to help save these spaces. They have introduced S.3349 / A.3190, which would provide the landlords of these spaces with a good portion of the rent due, and allow our venues to get back on their feet as we begin the long, slow process of returning things back to normal.

I see that [Representative] is not currently a co-sponsor of this legislation. Please ask your legislative director to look into S.3349 / A.3190. We need to pass it, or something like it, because small, community-based arts venues, like indie theaters, are vital to this city. They are economic drivers. They provide jobs. They provide a sense of community. New York just wouldn't be \*New York\* without the arts. We need your help to keep our independent arts spaces alive.
