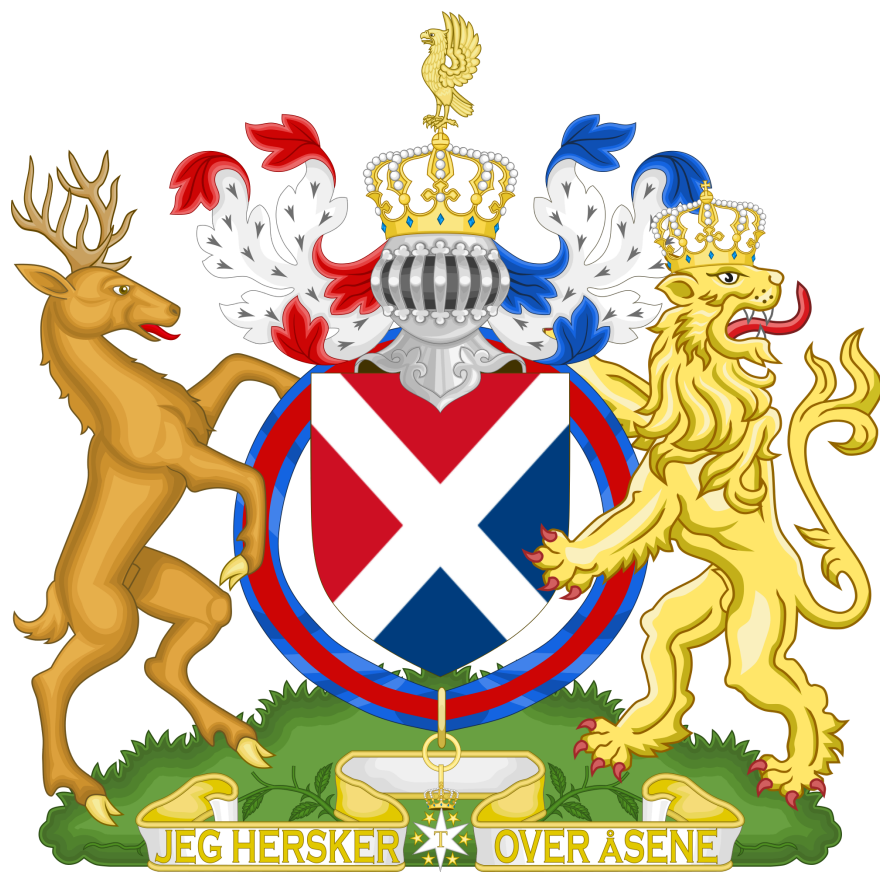




Constitution of the Kingdom of Oskonia

PREAMBLE

We the people of the Kingdom of Oskonia, a loyal group of noble individuals, swear our faith to the one and only Crown of our Glorious kingdom, which is hereby now known as the Kingdom of Oskonia.

We hold true that we shall advocate for the equality of all human beings, as we would like to be treated with equal respect. The equality of all shall hereafter be our greatest concern. The great People of Oskonia are proud to have this Great Constitution of our Great Kingdom.

We hold true that the King or Queen of the Kingdom of Oskonia is our one true ruler, and no impostors shall impersonate them. The purpose of the People of Oskonia is to have the best culture and national pride of any micronation or macronation that ever have been on the face of the Earth.

We hereby conjointly agree to all laws, concepts, and regulations stated in this written constitution, as this is the basis for the law and how different branches of the Oskonian government hereafter work. We understand this Constitution and what it stands for.

We hereby swear our loyalty to the Kingdom and the Monarch.

We formalize hereunder the precepts by which we conjointly agree to define our governance and pledge ourselves to this written constitution.

CHAPTER 1 - RIGHTS OF ALL CITIZENS

ARTICLE I

Every individual subject of the Crown of Oskonia is to be treated, hereby, with equal respect as any other person.

ARTICLE II

All subjects of the Crown of Oskonia are hereby granted the right to free speech.

ARTICLE III

All subjects of the Crown of Oskonia are hereby granted the right to freedom of religion.

ARTICLE IV

All subjects of the Crown of Oskonia are hereby not to be discriminated against because of their sexuality.

ARTICLE V

All subjects of the Crown of Oskonia are hereby subject to not be discriminated against because of their gender, regardless of if they were born with it or not.

ARTICLE VI

All subjects of the Crown of Oskonia are hereby granted the right to freedom of peaceful gathering.

ARTICLE VII

All subjects of the Crown of Oskonia are hereby granted the right to run for public Oskonian office.

ARTICLE VIII

All subjects of the Crown of Oskonia are hereby granted the right to free healthcare.

ARTICLE IX

All subjects of the Crown of Oskonia are hereby granted the right to free public State-funded schooling, although schools not within the state's funding shall still give educational services.

ARTICLE X

All subjects of the Crown of Oskonia are hereby granted the right to freedom of political affiliation.

ARTICLE XI

All subjects of the Crown of Oskonia are hereby granted the right to a fair trial in court, if they ever have criminal charges brought against them, such as murder, treason, or burglary.

ARTICLE XII

Any of the rights stated in the above articles may be replenished if the user of the rights is to cause harm by using these above mentioned rights in a harmful or hurtful way.

CHAPTER 2 - THE MONARCHY

ARTICLE I

The absolute power in the Kingdom of Oskonia is hereby granted to the Monarch of Oskonia, either a king or queen, who is blessed by the Grace of the one true God.

ARTICLE II

In the Kingdom, the monarch has half power. The other half is vested in Parliament.

ARTICLE III

The title of King/Queen of Oskonia is hereby a hereditary office.

ARTICLE IV

The ruling house of the Kingdom of Oskonia is the Royal House of David.

ARTICLE V

The monarch's powers are unlimited.

CHAPTER 3 - PARLIAMENT

ARTICLE I

The executive power in the Kingdom of Oskonia shall hereby be vested in the Parliament of Oskonia, with the Monarch's consent.

ARTICLE II

The Parliament shall be made up of one house.

ARTICLE III

A law hereby shall be introduced in the Parliament. If the Parliament votes yes on a law, the King has the final say, who can veto any law.

ARTICLE IV

Parliament members are granted unlimited office terms, with elections held regularly.

ARTICLE V

The Parliament is to be ruled by the Prime Minister of Oskonia, who presides over the Parliament and can break a tie vote in the Parliament.

ARTICLE VI

Meetings of the Parliament are to be held virtually via Discord, more specifically the official Kingdom of Oskonia Discord server.

CHAPTER 4 - RATIFICATION OF LAW

ARTICLE I

The ratification of a law is to be done through a process through Parliament.

ARTICLE II

The ratification of a law shall go like this: The law is introduced by an MP. The Parliament either votes Aye or Nay on it. If they vote Aye, the King reviews it, and grants royal assent.

This revision of our Constitution, written the thirty-first of May, two thousand and twenty one, is hereby ratified into law this day, the thirty-first day of May, two thousand and twenty one.
