

LPC Resources Roundup: Journal Best Practices Checklist

This document organizes LPC's resources related to journal publishing into a best practices 'checklist.' It isn't comprehensive or authoritative, but will hopefully provide a starting point. With the exception of the Shared Documentation, all resources listed are freely available. New resources will be added to this list as they are created. In the meantime, we suggest also keeping an eye on the <u>Library Publishing Workflows project</u>, which is investigating and documenting journal publishing workflows in libraries.

Rights and Agreements

- Do you have a Memorandum of Understanding (MOU) or other written agreement in place with the editor/s or sponsor/s of each journal?
 - Example MOUs can be found in the <u>Shared Documentation</u> (LPC member-only content)

- Does every journal use an author agreement to obtain necessary permissions from authors?

- Do you have a journal- or program-level copyright policy? Open access policy?

- Do you have a program-level diversity policy?

- Do you have a program-level preservation policy?

- Are all program staff and editors familiar with the <u>Committee on Publication Ethics</u> (COPE) Core Practices?

Identifiers and Indexing

- Do your journals provide Digital Object Identifiers (DOIs)?

- Are your journals indexed in the Directory of Open Access Journals?
 - Support for DOAI indexing
 - Tip: Even if you are not ready to apply for DOAJ indexing or your journals aren't eligible, the DOAJ application makes an excellent checklist for journal website and policy best practices!
