

We, the undersigned, agree to the following:

1. MIT affirms the fundamental premise of the Coalition for Palestine's demands: that any partnerships with an entity which has been cited for multiple human rights violations and against which plausible evidence exists to suggest that it has been committing genocide ought to end.
2. To substantiate this premise, MIT commits to the rapid adoption of the traffic light system, as described for gifts in the 2020 Suri Report, to be applied to research contracts and partnerships with a foreign entity, specifically any foreign entity related to a foreign government or military.
3. MIT commits to adapting this process in collaboration with faculty and students by May 10th to produce a binding evaluation system for **direct** sponsorship, **primary** sponsorship, and other **partnership** or **collaboration** relations in which a foreign entity is involved in **funding, sponsorship, development, receipt, or selection** of research objectives. This policy would extend to project proposals currently in the request or renewal phase.
4. To address the specific context and demands of the Scientists Against Genocide Encampment protest, MIT commits to **running a stress test of the developed policy** by May 15 using previous proposals from ongoing research projects under direct sponsorship by the Ministry of Defense of Israel (Sponsor ID: 001134), specifically: *Coreset Compression Algorithms* and *Autonomous Robotic Swarms*. MIT commits to adopting the policy only when these two partnerships with the Ministry of Defense of Israel fail to be approved by the policy, and therefore the policy would pass the stress test.
5. MIT commits to immediately **return the current funding** and find an alternate funding source that is not affiliated with the Ministry of Defense of Israel for the two current projects: *Coreset Compression Algorithms* and *Autonomous Robotic Swarms*. Additionally, MIT commits to giving \$20 million to the rebuilding of Gaza's educational infrastructure via verified programs chosen by faculty and students allied with the Coalition for Palestine.
6. MIT commits to **pausing the approval or renewal of projects**, effective immediately, affiliated with the Ministry of Defense of Israel until the previously mentioned process has been put in place.
7. MIT commits to **providing transitional funding** for graduate workers and research staff whose funding is disrupted by the termination of complicit partnerships and facilitating the implementation of that transitional funding process.
8. MIT commits to **provide amnesty** to all students that have been involved in protests since October 19, 2023.
9. MIT commits to **publicly announcing** the contents of this agreement simultaneously with the MIT Coalition For Palestine to the entire MIT community prior to the end of the Scientists Against Genocide Encampment.

10. MIT Coalition for Palestine commits that, should the aforementioned demands be met, the Scientists Against Genocide Encampment on Kresge Oval would **end within 48 hours** of the signing of this agreement.

This commitment by the institute will be codified in MIT policy, including on research contract procurement, by July 1st, 2024.
