INTRODUCTION (Cambria, Bold, size 12, Space 1,0)

The introduction contains the purpose of the article/research formulated and presented with an adequate introduction and avoids detailed references and presentation of research results. Urgency of the research, supporting facts and data should be included. The results of preliminary research should be explained as the basis of the research. Before mentioning the research objectives, a gap analysis should be described. The gap analysis states the differences between the research and previous research. At this point, the novelty will be apparent. The stance of the research should be included, whether it corrects, argues, or supports previous research. (*Cambria, size 12, Space 1,0*)

METHODS (Cambria, Bold, size 12, Space 1,0)

The methods used should be accompanied by references; relevant modifications should be described. Data analysis procedures and techniques should be emphasized in the literature review article. The research stages and analysis should be described in detail. (Cambria, size 12, Space 1,0)

RESULTS AND DISCUSSION (Cambria, Bold, size 12, Space 1,0)



Results and discussion should be presented in the same section, clearly and concisely. The discussion section should contain the benefits of the research results, not the repeated results section. The results and discussion sections can be written in the same section to avoid lengthy citations. Tables or graphs should show different results. The results of data analysis must be reliable to answer the research problem. References in the discussion section should not repeat the references in the introduction. Comparisons with previous research results should be included. (Cambria, size 12, Space 1,0)

REFERENCE

References in the article should cite the last name and year. If quoting from multiple authors, then it must be sorted by the most recent reference. If quoting from an article written by two authors, then all authors' names must be mentioned. Meanwhile, if quoting from an article written by three or more authors, it is cited by writing the name of the first author followed by et al. The citation must be written in the reference section. Each cited reference must be written in full in the reference section. Unpublished references are not recommended to be cited in the article. References should be written in accordance with APA style. This journal requires 80% of the references cited to be from national and international journals. (Cambria, size 12, Space 1,0)
