

# **Basis of Selection**

Student Branches are not required to apply for this award. The Selection Committee will gather the data from the IEEE OU Analytics database and based on the data, the winner will be chosen.



#### **Initial Guidelines**

All the Organizational Unit Nominations under the "**Special Activities Awards**" category, should fulfill the following criteria.

- Any OU can submit nominations for a maximum of four awards.
- All the Student Branch Chapters/Affinity Groups nominations should be made under the Student Branch.
- The project should not be coupled with any other project unless they are related and if related, it should be clearly proven in the report.
- When applying to Project Category Awards, the project should fall between 16th August 2024 and 31st July 2025.
- **Duplicated submissions of the same project for different awards** (applying one project for more than one award) will result in **disqualification**.
- Project reports including photos, promotional materials, testimonials, etc. **should be limited to five(5) pages** and in pdf format (can be opened in Adobe pdf viewer and Foxit Reader). Documents not adhering to these criteria will not be considered for evaluation.

## • Best Student Branch Project Award
