Executive Structure Repair Amendment

§1. The following shall be amended:

Executive Structure Act

§2. The specified statute shall be amended to say:

Article 1 - Department of Expansion

- **§1.** There shall be a Department of Expansion (DoEx) that shall be led by an Executive Officer called the Secretary of Expansion.
- **§2.** The duties of the DoEX shall be to attract as many new members to SimDemocracy as possible, help new members integrate into SimDemocracy and to assist the President with their Foreign Affairs duties.

Article 2 - Department of Community

- **§1.** There shall be a Department of Community (DoCo) that shall be led by an Executive Officer called the Secretary of Community.
- **§2.** The duties of the DoC shall be to plan and host community events, assist with the management of the social aspect of the SimDemocracy Discord server and to enrich and promote SimDemocracy's community and culture.

Article 3 - SimDemocracy Bureau of Investigation

- **§1.** There shall be a department called the SimDemocracy Bureau of Investigation (SDBI) that shall be led by an Executive Officer called the Director of the SimDemocracy Bureau of Investigation.
- **§2.** The duties of the SDBI shall be to enforce the in-game laws and police for in-game crimes, and to assist the Admins and Moderators in keeping watch for breach of out-of-game rules and community safety.

Article 4 - State Attorney's Office

- **§1.** There shall be a State Attorney's Office (SAO) that shall be led by an Executive Officer called the Attorney General.
- **§2.** The duties of the SAO shall be criminal prosecution, judicial record-keeping, and legal representation and counsel of the government.

Article 5 - Department of Archives

- **§1.** There shall be a Department of Archives (DoAr) led by an Executive Officer called the Secretary of Archives.
- **§2.** The duties of the DoAR shall be to document information about SimDemocracy in an easily understood and accessible way. They shall have access to the wiki on the r/SimDemocracy subreddit which they shall use to document this information, including but not limited to the following:
 - **§2.1.** All active political parties and their beliefs.
 - **§2.2.** All elections.
 - **§2.3.** All government officials, past and present.
 - **§2.4.** All votes by the Chamber of Representatives and Chamber of Commons.
 - **§2.5.** All current legislation.
 - **§2.6.** Significant historical events in SimDemocracy.

Article 6 - SimDemocracy Discord Server

- **§1.** At minimum, the President, Vice President and Chancellor shall be allowed to speak in an official announcements channel and a government announcements channel.
- **§2.** Every executive department shall have its own channel and roles in the SimDemocracy Discord server as necessary to conduct its business.

- **§3.** The heads of each branch of government and Executive Officers may control their own sections of the discord, including the channels and roles associated with them.
- **§4.** The President, Vice President and the Secretary of Community shall all have the permissions to manage the channels and roles of the SimDemocracy discord server that are dedicated for informal social purposes.
- **§5.** For Executive Officers, leaving the SimDemocracy Discord server for over 1 week shall be considered a resignation from all offices.
 - **§5.1.** There will be an exception if the official in question has gone on an announced vacation with a date of return specified.

Article 7 - Presidential succession

- **§1.** In the case that the office of President, Vice President and Chancellor are all vacant, the Presidential line of succession shall continue as follows:
 - **§1.1.** Secretary of Expansion.
 - **§1.2.** Secretary of Community.
 - **§1.3.** Director of the SimDemocracy Bureau of Investigation.
 - **§1.4.** Attorney General.
 - **§1.5.** Secretary of Archives.
