10th Anniversary Pizza Kneading Contest

Rules and Regulations November 11, 2023, beginning at 9am

- 1. Up to 30 competitors will be allowed to participate.
- 2. Pre-registration for the 10th Anniversary Pizza Kneading Contest is required. Contest registrations may be made online at the time of registration. No registrations will be accepted onsite at the contest without the authorization of show management.
- 3. Registration is free.
- 4. Competitors must be 21 years of age or older.
- 5. The dough ball will be 12 ounces in weight.
- 6. The goal of this competition is to see who can continuously knead their pizza dough the longest.
- 7. Judges will place one (1) dough ball for each competitor on the competition table.
- 8. Dough balls are not to be touched by the competitor until the contest begins. Dough replacement may be made before the start of the competition if judges agree.
- 9. The judge will count down "3 2 1 GO" and start the stopwatch on "GO." In the event of a false start, the competitor may be disqualified. In the event of a malfunction of the stopwatch, the judge will immediately stop the competition; the table will be reset with fresh dough balls, and the contest will start again.
- 10. Contestants may use only their hands to knead the dough ball.
- 11. Participants must follow the kneading guidelines: fold the dough ball in half and rock the palms of their hands forward to press the dough flat, rotate slightly, and repeat the process.
- 12. Contestants must knead every 3 seconds.
- 13. Removal of hands or inconsistent kneading during the competition will automatically result in disqualification.
- 14. Times will be measured to the hundredth of a second.
- 15. Competitors will all share the same start time for the stopwatch.
- 16. The judges' decision is final and may not be disputed. Any competitor who becomes belligerent or violent will be disqualified and removed from the area.
- 17. 1st place shall be awarded based on the longest pizza dough kneading time. First place will win ten (10) free Pizzas from Pizza Rock and ten (10) free nights at the Downtown Grand in the Gallery Tower, standard king, or double queen bedroom.
- 20. In the event of any unforeseen incident, the judges will consult official rules and organizers for advice and then hold a vote on how to deal with the issue. Judges' majority decisions are final.
- 21. The Downtown Grand Hotel & Casino is not responsible for injuries inflicted on the contestants through kneading the pizza dough.
- 22. Employees, as well as family and household members of Downtown Grand Hotel & Casino or Pizza Rock and their affiliates, may not participate in any Downtown Grand Hotel & Casino Promotions unless otherwise stated in official rules.
- 23. By participating in this promotion, participants agree to comply with all rules contained herein.
- 24. Show/event management is not responsible for typographical errors or omissions in these rules.
- 25. Management reserves all rights.
