

Palomar College Early Childhood Education Lab School (ECELS) General Lesson Plan Implementation Guidelines

Things to Know Before You Go:

- All student observers must wear an ID while at the ECELS. This can be a student ID or other official document with a photo (i.e., driver's license). The ECELS front office will provide observer/student badges to be worn.
- All students must sign in and sign out at the front office of the ECELS when they enter and exit the site.
- Students must agree to the <u>CHDV Statement of Commitment and Confidentiality</u>.
 - Students may bring their signed form with them or read and agree to the statement upon arrival.
- The ECELS is a Cell Phone Free Zone. Students using mobile devices may be asked to leave.
 - All cell phones should be off and stored away. No photography, texting, phone calls, or social media
 usage is allowed while observing or implementing an activity at the ECELS.
- We strive to protect the health and safety of our youngest Comets. If you are not feeling well, please stay home.

General Information

- All lesson plan activities must be approved by your professor as well as the ECELS classroom Lead Teacher.
- Appointments to meet the Lead Teacher must be set up 1 week before your implementation. The schedule of availability is on page 2 of this document.
 - a. Implementations cannot take place during lunch or nap times.
 - b. There are limited spaces available each day. Please don't wait until the last minute
 - c. The deadline for scheduling a lesson plan implementation is **December 1**.
- Children have a right to privacy. Observations in restrooms or during sleeping time are prohibited.
- For everyone's protection, please have a staff member present at all times. Students may never be left alone with children and must be supervised by a teacher or staff member at all times.
- Redirect family inquiries to an ECELS staff member.
- Wear clothing that is appropriate for a workplace. Please make sure that you can sit, squat, or bend over without exposing midriffs, breasts, or buttocks. No clothing or accessories with offensive graphics or words are allowed.
- Please refrain from interrupting teachers or staff while they are engaged with children or families.
- Bring only the materials needed for your activity
 - a. Large bags, purses, and backpacks with personal items, including cell phones and tablets, must be stored out of the reach of children.
- Contact your professor with questions about your assignment- do not ask the ECELS teachers or staff.

Students Facilitating a Lesson Plan or Activity

- 1. After contacting the Lead teacher (see page 2) and discussing the lesson plan, arrive at the agreed-upon time.
- 2. You will need to bring in all necessary materials and supplies for the activity.
 - The Lab School and teachers are not responsible for supplying the materials needed for your activity.
 - Some materials may need to be purchased at the student's expense.
 - Cooking activities must consider allergies. Remember to review all ingredients with the Lead Teacher.
 - The Lead Teacher may alter, adjust, modify, or limit the implementation of your lesson plan at any time for health and safety reasons.
- 3. If you think the Lab School might have a material you need (i.e., paintbrushes), get prior approval from the teacher when you call to set up your date and time.
- 4. Please bring enough materials to accommodate all the children in the classroom.
 - o Room 2: 10-12 children
 - o Rooms 3, 4, 5, 6, 7, and 8: 16-18 children
 - o Escondido's Rooms 9 and 10: 16-18 children
- 5. Plan on setting up the activity without interrupting the teacher or distracting the class.
- 6. Plan your classroom time appropriately. Here is a suggested implementation schedule: 10 minutes for setup, 20 minutes for implementation, and 10 minutes for cleanup.
- 7. After facilitating the activity, clean up all of your materials and leave the table or room exactly how you found it.
