KEY POINTS

Authority, or lack of it, is layered in 8 tiers. The pyramid peak is the top tear, i.e. The Rule Of Law.

In tier 2 lives every man and woman on the planet, under the Rule of Law - variously referred to as Common Law, God's Law or Natural Law. "Law" dies not mean legislation, which falls into tier 5. The Rule of Law is the supreme authority. Nobody is above the Law. NOBODY can tell anybody else what to do, without their consent. We are all equal under the law. We populate the second tier of authority as equals without heirarchy. No-one is born with more rights than any other. Everyone is obliged to obey the law in order to rely on its defence of their own rights.

The 3rd to the 7th tiers represent society and the heirarchy therein - a nation state for example. All positions named in these tiers are legal fictions, e.g. citizen, Judge, Prime Minister etc. These are "positions" of authority or subservience as the case may be, taken up by sovereign beings. If a man or woman accepts voluntarily a position in these tiers, they accept the heirarchy and responsibilities attached, and in so doing they relinquish their supremacy as a sovereign being in exchange for the benefits of being a member of that society. There is no compulsion to membership, but it stands to reason that where responsibilities exceed benefits and membership loses its attraction because it has become onerous and oppressive, then every man and woman has a right to revert to their supreme position as a sovereign being, thus abandoning their position in that society.

Our "Rights" are inalienable. They are not given to us. They are ours as of right. Our rights are conditional upon our duty to respect the rights of others. This is a mutually beneficial compact with fellow sovereign beings.

If the society with which we have aligned ourselves fails, we have a right to form new alliances and a new society; i.e. a new nation state. (Reference, Vattel's Law Of Nations).
