


Farmington Public Schools Updated Plan for Use of Funds

Existing Social Emotional Supports were and are being expanded with an SEL toolkit for staff via FastBridge (SEL Screening Tool) and Navigate 360 (SEL curriculum at the secondary level). Community, staff and student feedback continues to heavily support a focus on social emotional learning.

Staff costs were and are supported across the system and included but are not limited to the following:

- Refining curriculum and instructional priorities, maps and pacing guides in response to the pandemic
- Mentoring for at risk students
- Professional development to support students in special populations
- Staffing support for extended learning opportunities (summer and after school) offered free of charge to families
- Expand summer learning opportunities for students in special populations
- High Dosage Tutoring for grades 6th 12th
- Expanded tutoring after the school day in grades K 12th grade
- Expanded Community Support Services Department
- Middle school reading and math intervention staff
- Adding additional teachers and paraprofessionals to support EL/Bilingual students
- Elementary Support Coordinator to align Tier II and Tier III interventions
