## Team Sponsorship Agreement

### PARTIES:

This Sponsorship Agreement (the "Agreement") is entered into on \_\_\_\_\_, (the "Effective Date"), by and between:

### BACKGROUND:

WHEREAS, the Sponsor desires to provide financial support to the Team for the promotion of the Sponsor, the Team, the Chapter, and SSI;

WHEREAS, the Team is duly registered with the Chapter and SSI and is authorized to seek sponsorships;

WHEREAS, the Chapter has implemented the Team Sponsorship Policy to ensure transparency, accountability, and uniformity in the handling of team sponsorships.

NOW, THEREFORE, the parties agree as follows:

**I. SPONSORSHIP TERMS:**

1.1 Nature of Sponsorship: The Sponsor agrees to provide financial or in-kind support to the Team for the purpose of team apparel, merchandise, equipment<sup>1</sup>, coverage of team member registration fees and/or interpreter services to ensure inclusion and accessibility.

1.1.4 If any of the Team's monetary funds remain at the end of the year, the funds will be donated to Stonewall Sports DC.

1.2 Policy Compliance: All parties agree to adhere to the Chapter's Team Sponsorship Policy.

## **2. FINANCIAL ARRANGEMENTS:**

2.1 Funds Direction: All sponsorship funds, including monetary donations and in-kind contributions, shall be directed to SSI, as per the Team Sponsorship Policy.

2.3 Disbursement: After deducting the processing fee, the remaining funds will be transferred to the Chapter account for disbursement according to the policies outlined in the Invoice Submission and Approval Process sections of the policy.

## **3. UTILIZATION OF FUNDS:**

3.1 Invoice Submission: The Team shall submit detailed invoices to the Director, Sponsorships of the Chapter for the intended use of funds.

3.2 Approval Process: The Director, Sponsorships shall review submitted invoices to ensure alignment with the chapter's mission and values. Approved invoices will be processed promptly.

## **4. SPONSORSHIP BENEFITS:**

4.1 Acknowledgment: The Team agrees to provide the Sponsor with the agreed-upon benefits outlined above, including but not limited to logo placement, event acknowledgment, event hosting, and promotional opportunities.

## **5. COMPLIANCE AND PENALTIES:**

5.1 Policy Adherence: All parties agree to comply with the terms and conditions outlined in the Chapter's Team Sponsorship Policy.

5.2 Penalties: Violations of the policy may result in penalties, including but not limited to suspensions, removal from the chapter, and team disbandment.

**6. TERM AND TERMINATION:**

6.1 Term: This Agreement shall commence on the Effective Date and continue until \_\_\_\_\_ unless terminated earlier as provided herein.

6.2 Termination: Either party may terminate this Agreement for cause upon written notice if the other party breaches a material term and does not cure such breach within thirty (30) days of receiving notice.

7.1 Governing Law: This Agreement shall be governed by and construed in accordance with the laws of The District of Columbia.

7.2 Entire Agreement: This Agreement contains the entire understanding of the parties and supersedes all previous agreements and understandings between the parties.
