New Business

1. Access & Functional Needs Program Review for the group

- o <u>DHSEM AFN Training Engagement Dashboard</u> started creating trainings since 2021. ASL Interpreter training in April with 30 attendees. Shared Hannah's Dashboard data on number of trainings, where registrants came from and tribal participation, other states over the past several years. G197 have 29 states attended. Have changed names of trainings to increase chances of grant funding. Public Health and Human Services always served underserved and underrepresented. Moved to focusing on AFN Resources and away from AFN as a label.
- o G197 resulting in good results and are able to better reach out to community members, provide training at LEPC conference and break down units into separate workshops focusing on people, places, things, and money. Using a social model. Another topic will be How to develop an AFN steering committee
- o Move CMIST Teams to CMIST Assistance Teams so they can used in teams that already exist.
- o Priorities from Team Members
 - Curt needs community partners to be more involved in new CDOO grant, including emergency management. Atlantis will develop an engagement group. Looking to increase more individual EP plans and work with local EM. Disseminate and collaborate more with state.
 - Candise doesn't currently have anything scheduled, but has been in contact with Jaclyn to get something for this fall.
 - Amy CDPHE is holding off for now because of funding.

6. Updates from the group

- How programs are being affected financially by changes at National and State levels
- o Sadie National events are not affecting the DHSEM AFN program, some emergency management programs are affected. In fiscal year 2027 may lose \$7,000. ASL and captioning activities can ask for reimbursement.
- o Amy public health ep and hospital preparedness grants will receive less funding. Health Care Coalitions have received stop work orders until hospital preparedness grants are reinstated. All 9 regions using coop plans. Adjusting to lower funding. Not replacing positions and redistributing staff.
- o Candise funding cut some, but don't know what changes are coming. Helping AAAs deal with less funding. Medicaid and SNAP programs will cause a large impact.



Department of Public Safety

- o Kristina fully funded through this fiscal year, but looking at future cuts. Disability Law Colorado looking at cuts and UCEDDs have no funding.
- o Eileen no federal funding so not affected. State funding (dental program) not affected. Awarded grant through Denver for mental health services for unhoused individuals.
- o Clessie no federal funding used for payroll, but changes made for programming, large program changes with Medicaid, Medicare and SNAP. Lack of health care coalitions making a huge impact. Found some grant monies for the health care coordinator through the end of the month.
- o Marrisa grant writer for Atlantis, 60% federal, 40% state funding. Received CDOOE grant to support Curt's EP program. Having conversations about the future with community partners.
- o Alison no federal funding. All funding from old license plates. Don't have access to \$\$ until legislation gives it to them. Looking at significant reduction this year, but looking at an increase next year. Question regarding use of DEI language. Try to push back on removal of DEI language.
- o Serena all four public health staff funded through CDC, working with partners to help with stop work orders. Have funding through the end of August with grant funds, but waiting for final notice for PHEP funding. Looking at large cuts next federal year. Being creative. Other jurisdictions are also looking at other funding opportunities.
- o Veronica don't anticipate getting any more funding. Removal of DEI language will make a big impact. Won't impact financial contributions for the conference.
- o Sadie AFN University coming up in August have 60 registrations with a sizable number from out of state. Have completed 7 G197 trainings with 2 scheduled for the fall. Need to include agricultural industry and college campuses. Looking to make a stronger rural focus.
- o Curt 35th ADA celebration with RTD on August 1st from 9-3 and Atlantis turns 50 this year. Registration required.
