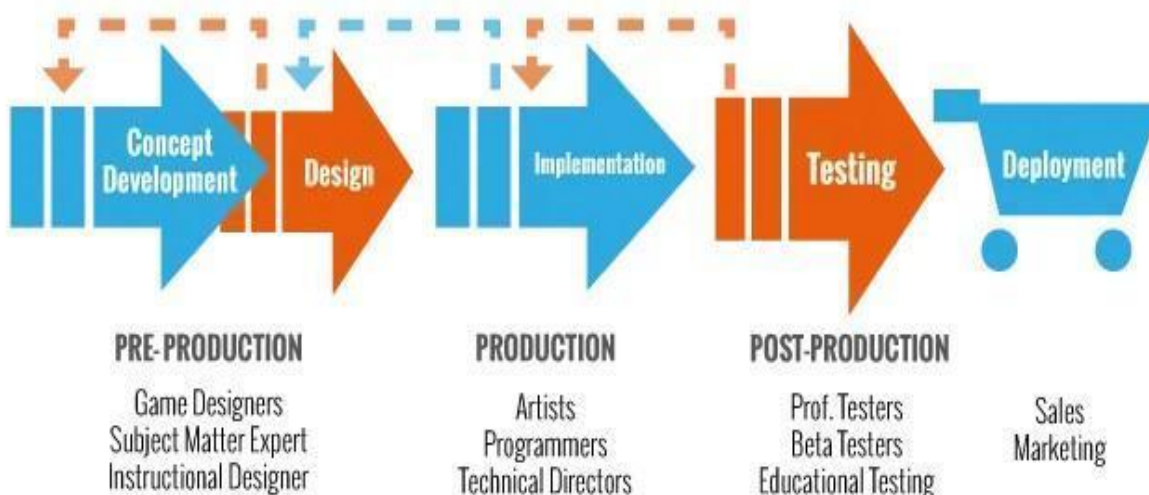


Figure 1 Cycle Production

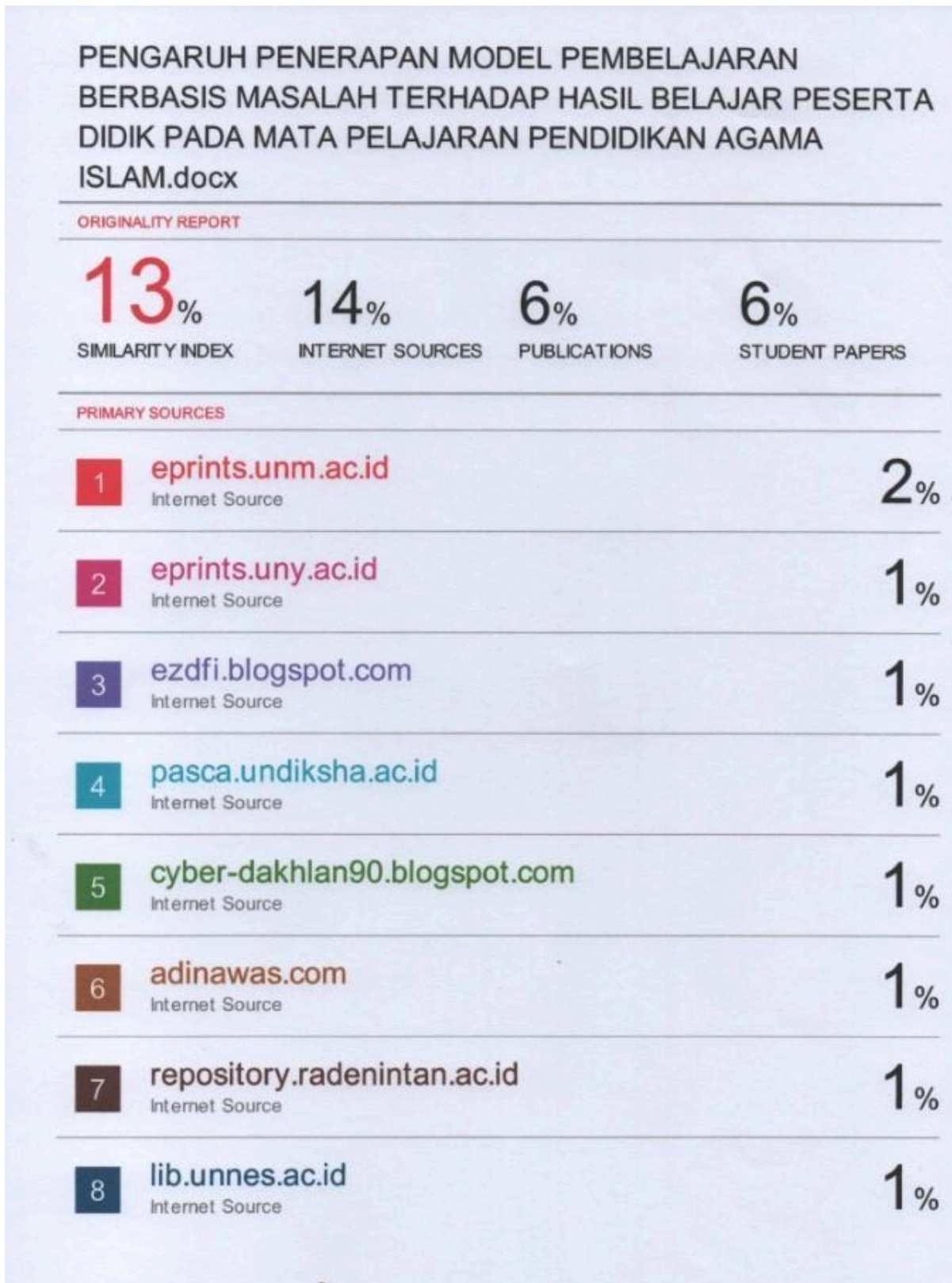
