Privacy Policy - Pleasure Roots, LLC

Introduction

This privacy notice discloses the privacy practices for **Pleasure Roots, LLC** and our websites; https://pleasureroots.com and https://pleasurerootsmembers.com. This privacy notice applies solely to information collected by these websites, except where stated otherwise. It will notify you of the following:

- What information we collect;
- How your information is stored;
- With whom it is shared;
- How it can be corrected;
- How it is secured;
- How policy changes will be communicated; and
- How to address concerns over misuse of personal data.

We only control the content on this website and not the data protection practices on any other site. Every user is encouraged to review the Privacy Policy of any third party site. We may change this Privacy Policy from time to time. You should check this page from time to time to ensure that you have seen any changes as you are bound by them implicitly through your use of our website, program, products and services.

Use of the data that you provide to us, or which is collected by us on or through our websites, programs, products or services is governed by this Privacy Policy. By using or purchasing our websites, programs, products or services, you agree and consent to this Privacy Policy.

Our websites, programs, products, and services are owned and operated by Pleasure Roots, LLC ("Company", "we", or "us"). The term "you" refers to the user or client of our websites, programs, products, or services. The term "Services" may refer to either the Company's websites, programs, products or services.

Information Collection, Use, Sharing, and Storage

We are the sole owners of the information collected on this site. We only have access to/collect information that you voluntarily give us via email or other direct contact from you. We will not sell, rent, or share this information to anyone unless given explicit consent to do so.

What We Collect. We may seek personal data including your full name, email address, and other contact information like your physical address, billing information, and credit card data, namely when you join our mailing list via our websites, or purchase our programs, products or services. You may select to not provide any of the above info, but you will then not be able to use Company services or certain features. By providing such information to us, you grant us permission to use and store such information. We, in

turn, will use our best efforts to keep such information safe and secure. We may also collect the following information: (i) name and job title, (ii) contact information including email address, (iii) demographic information such as location, preferences and interests, (iv) information relevant to customer surveys and/or offers, (v) information that you provide through your program, product or service participation. If you believe that any information we are holding on you is incorrect or incomplete, please contact us as soon as possible. We will promptly correct any information found to be incorrect.

We may collect and store certain information about your interaction with Company website and services, including cookies, IP Addresses, browser type, device type, location, Internet service provider (ISP), entry and exit pages, operating systems, time/date stamps, and other related data.

What We Do With the Information We Gather. We will use your information to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request, e.g., to ship an order.

We request and require various information of a personal nature to understand your needs and provide you with a better service. In addition, we may gather such information for the following reasons: (i) internal record keeping, (ii) to improve our websites, programs, products and services, (iii) to periodically send promotions about new programs, products or services or other special offers from which you may unsubscribe at any time, (iv) for aggregate, non-identifiable data for market research purposes, and/or (v) to customize the respective program, product or service you purchase or use according to your interests. Company uses this information, only to improve the quality of our services and products.

We may contact you via email in the future to tell you about specials, new products or services, or changes to this Privacy Policy. You can opt out of this at any time.

Storage. All information is stored through a data management system within the United States. This information can only be accessed by those who help manage that information in order to deliver email or otherwise contact those who would like to receive our correspondence. You agree and acknowledge that Pleasure Roots, LLC and those who manage the data management system may have access to your personal information. We will keep your data for up to 30 days after your account is deleted. After the 30 days all your data is fully removed from our system.

Retention policy. We securely store your information, and hold it for as long as we need to in order to provide our services and products to you in accordance with (i) applicable law, or (ii) as long as is set out in any relevant contract you have with us.

Sharing. We share aggregated demographic information with our partners and advertisers. This is not linked to any personal information that can identify any individual person.

We use an outside shipping company to ship orders, and a credit card processing company to bill users for goods and services. These companies do not retain, share, store or use personally identifiable information for any secondary purposes beyond filling your order.

Orders. We request information from you on our order form. To buy from us, you must provide contact information (like name and shipping address) and financial information (like credit card number, expiration date). This information is used for billing purposes and to fill your orders. If we have trouble processing an order, we'll use this information to contact you.

Individuals under 18. We do not intentionally, or knowingly, process personal information from individuals under the age of eighteen (18). When necessary, users under the age of eighteen (18) will be told not to submit any personal details. We will make every effort to delete any details of such users where a parent or guardian has informed us that these details have been collected.

Your Access to and Control Over Information

You may opt out of any future contacts from us at any time. You can do the following at any time by contacting us via the email address or phone number provided on our website:

Your Rights

You also have the right to ask for us to update, delete or stop processing information we hold about you. However, please note that there are circumstances in which complete erasure of your information or ceasing to process your information will not be possible for operational, legal and business reasons. This may include if you remain a customer for whom we need to provide services, but wish us to no longer contact you for marketing purposes. In this case we may need to retain some of your details securely in order to facilitate this request by, for example, keeping you on a "do not contact" or suppression list. This will be the only purpose for which your data will be used if this is the case.

You have the right to ask us to not process your personal data for marketing purposes. You can exercise this right by contacting us at support@pleasureroots.com and you can unsubscribe from all content at any time.

Enrollment and Registration

In order to use our programs, products or services, a user must first complete the registration form. During registration a user is required to give certain information (such as name and email address). While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only employees who need the information to perform a specific job (e.g. billing or customer service) are granted access to personally identifiable information. The computers/servers on which we store personally identifiable information are kept in a secure environment.

Viewing by Third Parties. Note that whenever you make your personal information available for viewing by third parties through our programs, products or services, such as on or through our website or our private Facebook Group page(s), the information you share also can be seen, collected and used by third parties, and therefore, we cannot be responsible for any unauthorized third party use of such information that you voluntarily share online or in any other manner.

Business Transitions. In the event that Company goes through a business transition, such as a merger, acquisition by or with another company, including partial or all assets, any personally identifiable information we have on record will likely be transferred with the transition.

For Subscriptions. We employ and protect all data with SSL encryption and other security measures to ensure you that your data is protected and safe. Cookies
