  - iii. If we would like additional copies, you will arrange for us to purchase these from the publisher at the standard trade discount.
  - iv. If images are published electronically on blogs etc., you will link back to the respective Trust's website and/ or social media pages, and send us the links so that the Trusts may share the content on their own platforms with due credit to you.

**B. For critical editions of MSS from the MSMS II Museum Trust collection only:**

- a. The Trust will supply images free of cost for critical editions, and will not seek royalties.

- b. The main publisher will credit the Trust as co-publisher when it is based on the Trust's manuscripts (30% or more). In case it is less than this proportion, the Trust will be credited as a supporter on the preliminary pages ('Published with the support of the Maharaja Sawai Man Singh II Museum Trust, Jaipur').
- c. The main publisher will supply 20 copies to the Trust free of charge, and sell any additional quantities to the Trust at the standard trade discount. Whenever and every time that new prints runs are made or revised editions are printed, the Trust will be supplied with 10 additional copies free of charge.
