Personal information we collect

The personal information that we collect about you through the App depends on how you interact with us:

- Information that you provide voluntarily

- Information that we collect automatically

The App may collect certain information automatically from your device when you use it, such as information about the device or browser that you are accessing the App from or diagnostic data. The App may also collect information about how your device has interacted with the App, including the pages accessed and links clicked. - Third party service providers and vendors who provide services, including data processing services, for the Organization, for example, Pushpay.

Data security
