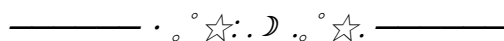


## Terms of Service

- If you are not using my [commission form](#) to order, please be as descriptive as possible about what you're wanting for the commission
- Please do not remove my signature/watermark, take credit for, alter, or commercially use my work without my consent
- Commercial rights to commissioned work can be purchased for 700% (or 900%, depending on the project) of the original commission price. With this, you can use the artwork for merchandise, books, promotional work, etc. You must credit me, the artist, for the artwork no matter what.
- At least partial payment is required upfront. If full payment isn't sent before I start, progress will be paused after the sketch phase until the invoice is paid in full. Once the invoice is fully paid, progress will continue.

- Once payment is sent, it belongs to the artist. Commissions are non-refundable once progress has started
- I will regularly update you with progress to make sure things are progressing to your liking!
- Requesting major changes beyond the sketch phase will require an extra charge depending on how much you want changed.
- The finished work will be posted to my social media pages/galleries, though I can refrain from publishing for a time (such as if the piece is a surprise gift you want revealed at a certain date).
- Let me know if you'd prefer to not be tagged when I publish an artwork
- You may use or re-upload the finished work for any non-commercial purpose as long as I'm credited and linked back to
- *Any statement can be bound to change if discussed with me, the artist, prior to the commission.*

- You may make any desired changes to the art and/or design of your purchased adoptable(s) ; as long as I'm credited for the original version
- You may reupload/use the art of the purchased adoptable as long as I'm credited and linked back to
- If you plan to resell a design, please do so for the price you bought it
- Commercial rights to a design can be purchased for 600% of the adoptable price. With this, you can use the design for making adoptables/closed species, merchandise, books, promotional work, etc. You must credit me for the original design no matter what.

*Disclaimer: Sometimes I'll make adoptables with similar designs as each other, and sometimes I'll do custom designs that are reminiscent of past adoptable design(s) if a client requests this. There is no guarantee if you purchase a premade design from me that it won't have similarities with a past or future design. Sometimes I will reuse traits, palettes, etc, especially if I'm commissioned to do so (with exceptions ofc).*
