

## OJT Grant Writing Assistance Program

### About the Program

The [Office of Just Transition](https://cdle.colorado.gov/the-office-of-just-transition) is providing free grant writing services to Coal Transition communities, listed below, to apply for state, federal and private foundation grants.

### Who is Eligible for Free Grant Writing Support?

Eligible entities in Coal Transition Communities may apply for grant writing support. Eligible entities include development districts, counties, municipalities, or other political subdivisions of the State (including public K12 schools and special districts), Tribes, Registered apprenticeship programs, Institutions of higher education, Public or private nonprofit organizations or associations. Tier One Transition Communities are those that will be most impacted by recent and upcoming coal facility closures and will be generally given priority.

#### Tier One Coal Transition Communities:

- Morgan County
- Pueblo County
- The West End of Montrose County (includes the Town of Norwood in San Miguel County)
- The Yampa Valley (Moffat, Rio Blanco, and Routt counties)

#### Tier Two Coal Transition Communities:

- Delta and Gunnison counties
- El Paso County
- La Plata County
- Larimer County
