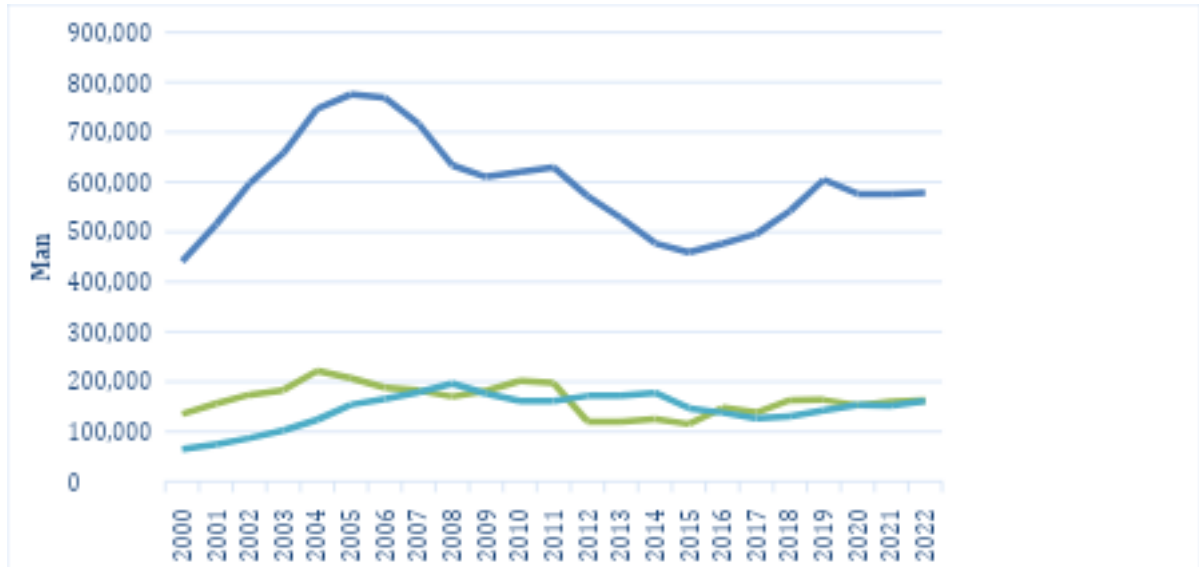

## Rules of article design

### Please read and adhere to the following specifications carefully:

- Potential journal authors should follow the following IMRAD article structure rules according to the headings: (introduction (problem statement, objectives, background), research methods, discussion/results, conclusion).
- The length of the article (excluding title, author information, abstract, keywords, bibliography list) should not be less than 6 pages (3,000 words) and not exceed 16 pages (7,000 words).
- Ensure that the manuscript is consistent with the [purpose and theme of](#) the journal.
- Customise the manuscript according to the template without changing the format or style.
- Send the manuscript in .doc or .docx format.
- Text editor parameters: margins - 2 cm on all sides; width alignment; font - Times New Roman, size - 14; line spacing - 1; paragraph indent - 1 cm; page orientation - portrait.
- Make section headings bold and centred.
- Figures and tables should be centred without indentation after the first mention in the text and cited as (Figure 1) or Figure 1, keeping within the page margins.
- Figure and table captions should be self-contained, descriptive and centred; figure captions should be placed at the bottom and table captions at the top.
- Multiple figures can be placed in a single row and cited together (e.g., Figure 2 or Figures 3 and 4).
- To align multiple figures in a row, use an invisible table and centre the captions accordingly.
- When referring to more than one figure or table, use hyphens and commas (e.g., Figures 6-8 or Figures 6, 7, 8-9).
- Use at least one figure or table and provide a detailed description of it (trends).
- Use the standard formula editor for equations, number them as (1) and cite them as Ur. (1) or Ur. (1-3) for more than one.
- The tool - [Zotero](#) (GOST style) should be used to design bibliographic references
- References must necessarily include scientific papers from the last five years (at least five).
- For Cyrillic language links, use the online transliteration tool -
- The reference list should be 12 point font size and aligned to the width.
- Ensure that the authors' [ORCID](#), name, degree, title, position, workplace, and email are correct.
- Make sure all funding sources are listed.
- Indicate the respective contributions of each author.
- Indicate potential conflicts of interest or declare none.
- Indicate the use of AI (e.g. ChatGPT) as recommended by [COPE](#) or state that no AI was used.
